# Hydrogenation of nanodiamonds using MPCVD: A new route toward organic functionalization

#### ABSTRACT

Nanodiamonds (NDs) emerge as excellent candidates for biological applications but their functionalization is 22 still an issue. By analogy with hydrogenated diamond layers, an efficient and homogeneous covalent 23 functionalization can be achieved on hydrogenated NDs. Here is reported an efficient new approach to 24 hydrogenate NDs by reducing all various oxygenated groups into C–H terminations. The hydrogenation 25 treatment is performed by exposing the nanoparticles to microwave hydrogen plasma in the gas phase. The 26 hydrogenation of the nanoparticles has been carefully characterized by FTIR and XPS analysis revealing 27 strong modification and homogenization of their entire surface. To validate this hydrogen treatment, 28 functionalization of the NDs has been conducted by using diazonium reactions. An efficient grafting was 29 observed for the hydrogenated NDs compared to the as-received ones.

#### 1. Introduction

Recent developments in nanosciences and nanotechnologies have 37shown that diamond nanoparticles or nanodiamonds (NDs) are of 38 high interest owing to their outstanding mechanical and optical 39 properties associated with their good chemical stability [1-3]. Since 40the demonstration of their low cytotoxicity [4-6], NDs are considered 41 as promising materials for biological applications [7]. Actually, 42nanodiamonds are studied for drug delivery applications [8]. NDs 43 exhibit also remarkable luminescence properties with emission of 44 45 great stability and of high quantum yield which originate from color centers (such as Nitrogen-Vacancy centers), naturally present or 46 induced by ion beam irradiations in the diamond lattice [2,9,10]. 47 Consequently, NDs emerge also as excellent candidates for biolabeling 48 49 applications [6].

For the development of such applications, functionalization of the 50NDs is required. The carbon surface of diamond constitutes an 5152excellent support for covalent functionalization. However, as reported in the literature, direct covalent functionalization of NDs appears to be 53 a limiting step, since efficient grafting may be restricted by the 54complex surface of the raw NDs. Mainly due to oxidizing post-5556synthesis treatments, NDs are covered by a wide variety of oxygenated functions: hydroxyl, ether, ketones or carboxylic acid 57groups [10]. This scattered superficial chemistry prevents an efficient 58

and homogenous functionalization due to different reactivity of these 59 various oxygenated groups. 60

Different experimental pathways have been explored to better 61 control the surface termination of NDs. The first one is the oxidative 62 treatment of NDs with strong acids leading to the formation of COOH 63 groups on the surface which can then react with alcohols or amines 64 derivatives [11–13]. Another approach reported by Krueger et al. [10] 65 consists in reducing all oxygen-containing surface groups to OH 66 functions with borane, then allowing the grafting of a variety of 67 silanes [14] or long alkyl chains [15]. Halogenation of NDs has been 68 also reported such as the thermal fluorination of detonation diamond 69 by Khabashesku and coworkers [16], and the cold-plasma functiona-70 lization used by Ray et al. [17]. Fluorinated NDs can then react with 71 nucleophilic reagents in substitution reactions leading to amino or 72 acid terminations [16].

By analogy with diamond films, another promising way to 74 homogenize NDs surface is the hydrogenation. Indeed, by reducing 75 all oxygenated terminations into C–H groups, this treatment ensures a 76 reproducible and versatile surface for further functionalization. 77 Furthermore, hydrogenated terminations confer on diamond films 78 specific electronic properties, allowing particular grafting approaches 79 based on physico-chemical activations. In pioneering works, Hamers 80 and coworkers [18,19] reported on functionalization of hydrogenated 81 diamond surface by photochemical reaction under UV illumination 82 with a long-chain unsaturated amine, being the first step to DNA-83 modified diamond surface. Based on the same photochemical method, 84 Christiaens and coworkers [20] overcame the problem of insufficient 85 carboxylation by attaching fatty acid chains to the diamond surface 86 and created a universal coupler for amino groups. Still on 87

hydrogenated diamond surfaces, Lud et al. [21] presented the grafting 88 89 of one monolayer of nitrobiphenyl by using the corresponding diazonium salt. Spontaneous reaction of diazonium derivatives on 90 91diamond hydrogenated surfaces was also reported by Boukherroub and coworkers in the presence of sodium dodecyl sulfate [22]. In the 92same way, Shul et al. [23] reported on solvent-free functionalization of 93 hydrogenated surface by aryldiazonium salts in ionic liquids, and 9495suggested that the electron necessary for reduction of diazonium salt 96 are most likely provided by the hydrogenated diamond surface.

97 By analogy with these works, a large field of functionalization 98 methods is potentially offered to hydrogenated NDs (H-NDs). Indeed, first promising results concerning surface grafting of 99 hydrogenated particles have been recently reported. Yeap et al. 100 101 [24] has described the functionalization of NDs with aryl organics using Suzuki coupling reaction, starting from partially hydrogenated 102 NDs (presence of hydroxyl groups at the surface) and they showed 103 that diazonium coupling can occur on these NDs. Regarding 104 electronic properties provided by hydrogenated terminations, a 105detailed study on hydrogenated micrometric diamond powder was 106 conducted by Chakrapani et al. [25]. They demonstrated an electron 107 transfer from the diamond to the surface, deduced from zeta 108 potential measurements, leading to a surface conductivity. It would 109 110 be interesting to know whether such specific chemical and electronic properties of hydrogenated diamond surfaces can be 111 also obtained on hydrogenated NDs. 112

To take advantage of the promising properties of H-NDs, the initial 113 treatment conferring the hydrogenated terminations is crucial and 114 115has to be carefully optimized. In the literature, only few example of hydrogen treatments performed on NDs deposited onto substrates 116 have been reported, using either atomic hydrogen exposure under 117 ultra-high vacuum (UHV) [26,27] or microwave hydrogen plasma 118 119 [24,28]. These methods seem to be efficient in terms of surface 120 modification but lead only to a partial hydrogenation of the NDs 121 surface. Moreover, some chemical interactions can take place between NDs and the substrate during the hydrogenation treatment [28]. To 122the best of our knowledge, there is no reported method providing 123hydrogenation of the whole NDs surface. 124

Here, we report on a new approach allowing the full hydroge-125 nation of NDs by exposition to hydrogen Microwave Plasma 126Chemical Vapor Deposition (MPCVD). NDs are treated in the gas 127phase allowing the modification of their whole surface by reducing 128 oxygenated terminations into hydrogenated ones. Furthermore, the 129present method is able to treat a large amount of NDs simulta-130 neously, (hundreds mg), which is a prerequisite to a meaningful 131 surface functionalization. Two kinds of NDs have been studied 132which are produced either by High Pressure High Temperature 133 134(HPHT) or detonation processes. These NDs mainly differ by their size and the graphitic shells surrounding the sp<sup>3</sup> core for detonation 135NDs [29]. Surface modifications of the NDs induced by the hydrogen 136plasma exposure have been carefully characterized using X-ray 137Photoelectron Spectroscopy (XPS) and Fourier Transformed Infra-138 139Red Spectroscopy (FTIR). Finally, to validate the hydrogen treat-140 ment, functionalization on these H-NDs has been conducted by using diazonium reactions. 141

#### 142 2. Experimental

#### 143 2.1. Chemicals

High Pressure High Temperature (HPHT) NDs (mean diameter:
50 nm) were purchased from Van Moppes (Syndia® SYP 0-0.05).
Detonation diamond NDs (mean diameter of primary particles: 5 nm)
were provided by NanoCarbon Research Institute Ltd. Acetonitrile
(Riedel-De Haën), pentane (VWR) and 4-nitrophenyldiazonium
tetrafluoroborate (Aldrich) were used as received.

#### 2.2. MPCVD hydrogenation

NDs were used as-received. 100 mg of NDs was deposited in a 151 quartz cartridge which was introduced in a quartz tube. This system 152 was introduced into the microwave waveguide cavity (Fig. 1). After a 153 pumping stage, the hydrogen was injected up to 10 mbar. Hydrogen 154 plasma was generated in the quartz tube with a microwave power of 155 300 W. To limit the temperature of NDs, the quartz cartridge was 156 sequentially removed from the waveguide for few seconds. A rotation 157 of the quartz tube was also applied to mix and homogenize the NDs in 158 the hydrogen plasma. After exposure, H-NDs were collected in dry 159 pentane under hydrogen flux and stored under controlled atmosphere to avoid any spontaneous surface oxidation by air. 161

20 mg of as-received or hydrogenated HPHT and detonation 163 nanodiamonds were reacted with 60 mg  $(2.5 \ 10^{-4} \text{ mol})$  of 4- 164 nitrophenyldiazonium tetrafluoroborate in 25 mL of acetonitrile 165 during 12 h. All experiments were conducted under vigorous stirring 166 and under controlled atmosphere. After reaction, NDs were washed 167 by 5 successive centrifugation-redispersion cycles in acetonitrile and 168 then the solid residue was dried under vacuum. 169

2.4. Characterizations

XPS analyses were performed using an Omicron XPS spectrometer 171 equipped with an Al K $\alpha$  monochromatized anode ( $h\nu$  = 1486.6 eV). 172 The binding energy scale was calibrated versus the Au 4f 7/2 peak 173 located at 84.0 eV [30]. The penetration depths are given by the 174 inelastic mean free paths for C1s core levels, close to 3 nm [31]. Curve 175 fitting procedure was performed to extract the components in the C1s 176 spectra, using a fixed Gaussian/Lorentzian ratio of 30%. Peak areas 177 were determined following the Shirley's inelastic background 178 subtraction method. Atomic ratios were calculated from the integrat- 179 ed intensities of core levels after photoionization cross-section 180 corrections. The component ratios  $C_x/C_{total}$  correspond to the 181 integrated intensity of each peak  $C_x$  over the total area of the C1s 182 spectrum. To avoid air exposure, immediately after hydrogenation a 183 small amount (few mg) of H-NDs (HPHT or detonation) covered with 184 a drop of pentane was deposited on the sample holder and introduced 185 directly in the UHV set-up equipped for surface analysis. 186

FT-IR spectra were measured in a transmission mode using a 187 Thermo Nicolet 8700 spectrometer. KBr pellets (150 mg) were 188 prepared using 5 mg of as-received, H-NDs (immediately after 189 hydrogenation) or functionalized NDs. Background signal was 190 recorded using a pure KBr pellet. Depending on the experiment, KBr 191 pellets containing or not NDs were dried in a dessicator for one day 192 under primary vacuum.

Powder X-ray diffraction patterns were acquired on a X'Pert 194 Philips diffractometer (40 kV, 40 mA) with CuK $\alpha$  radiation 195 ( $\lambda$  = 0.154056 nm). 196

#### 3. Results and discussions

#### 3.1. MPCVD hydrogenation

Hydrogenation of the diamond nanoparticles was performed on 199 as-received HPHT and detonation NDs using MPCVD hydrogen 200 plasma. The experimental set-up is shown on Fig. 1 and described 201 in experimental section. FTIR spectra of as-received and hydrogenated 202 NDs are reported on Fig. 2. For as-received HPHT NDs (Fig. 2a), a broad 203 band is observed at 1775 cm<sup>-1</sup> characteristic of C O stretching band 204 involved in carboxylic acid groups and anhydride functionalities [32]. 205 This band is less intense for as-received detonation NDs (Fig. 2b), and 206 due to their smaller size the signal is shifted to 1730 cm<sup>-1</sup> [33]. For 207

both kinds of NDs, a large band centered at  $1050 \text{ cm}^{-1}$  indicates the presence of hydroxyl groups. Signals located at 1635 and around  $3300 \text{ cm}^{-1}$  originate from adsorbed water in the KBr pellet and on NDs [34].

For detonation NDs (Fig. 2b), after a hydrogenation treatment of 10 min, a complete vanishing of the C–OH band at 1050 cm<sup>-1</sup> is observed, while the CO bond at 1730 cm<sup>-1</sup> still remains. After a similar second hydrogenation treatment (10 min), this band completely disappears. Concerning HPHT NDs, after a continuous plasma treatment of 20 min, the strong contribution of the CO band at 1775 cm<sup>-1</sup> is totally eliminated as well as the band related to

hydroxyl groups at 1050 cm<sup>-1</sup> (Fig. 2a). For both kinds of NDs, the 219 signals at 1635 and 3300 cm<sup>-1</sup> are still present on the FTIR spectra 220 after hydrogenation treatment (Fig. 2a\_b). Their disappearance after 221 drying the KBr pellet confirms these two bands are related to 222 adsorbed water (Fig. 2). On dried H-NDs, signals located around 223 2900 cm<sup>-1</sup> are exalted. These bands have been previously assigned to 224 C-H stretching of the hydrogenated NDs surfaces [35]. 225

XPS analyses were carried out on as-received and H-NDs to 226 investigate surface modifications induced by the hydrogenation 227 treatment. For as-received NDs, XPS spectra exhibit the presence of 228 carbon and oxygen on the NDs. From O1s and C1s core levels areas, 229 atomic concentrations were calculated for as received NDs and led to 230 an oxygen ratio of 18.0 at.% for both kinds of NDs (HPHT and 231 detonation). After hydrogenation, an important decrease of the 232 oxygen peak occurred. An oxygen atomic concentration of 6.6 at.% 233 was estimated for HPHT H-NDs. However, XPS general survey also 234 exhibited the presence of silicon species (2.4 at.%) after the treatment, 235 probably due to a slight degradation of the quartz cartridge. The study 236 of the Si2p core level revealed the presence of SiO<sub>x</sub> (1 < x < 2) species 237 and by taking into account the position and the area of the Si2p core 238 level [36], correction of the oxygen atomic concentration was 239 achieved. The corrected value of oxygen linked to NDs was thus 240 estimated to 3 at.% and for both kind of NDs. 241

Fig. 3 shows the C1s core levels spectra of NDs before and after 242 hydrogenation. For as-received HPHT (Fig. 3a) and detonation NDs 243 (Fig. 3b), a main peak is observed at 286.3 and 286.9 eV respectively 244 which can be assigned to the C–C sp<sup>3</sup> diamond bonds. These two kinds 245 of NDs mainly differ by their oxygen-carbon components located at 246 higher energies between 287 and 292 eV. C1s core level of the as- 247 received HPHT NDs clearly exhibits a component located at 290.5 eV, 248 related to carboxylic groups, and a shoulder between 287 and 289 eV, 249 assigned to hydroxyl and ether functionalities [37]. The broader C1s 250 peak of the as-received detonation NDs (FWHM = 3.0 eV) points out a 251 more important contribution of the components related to hydroxyl 252 and ether groups (between 287 and 289 eV), while the component 253 related to carboxylic groups is weak. These observations are in 254 agreement with the FTIR analysis which shows higher signal for 255 carboxylic groups in the case of HPHT NDs. After hydrogenation, a 256 strong modification of the C1s spectra is observed for both NDs. For 257 HPHT particles (Fig. 3a), a shift of the main peak from 286.3 to  ${\rm 258}$ 284.9 eV occurs and the full width at half maximum (FWHM) is 259 reduced from 1.8 to 1.3 eV. For detonation NDs, the initial broad C1s 260 core level is also strongly modified with a shift from 286.9 to 285.0 eV 261 associated with a narrower FWHM from 3.0 to 1.5 eV. An important 262 point is that noticeable differences of the C1s core levels exhibited by 263 the as-received HPHT and detonation NDs, especially for high binding 264 energy components, almost disappear after hydrogenation, leading to 265 nearly similar C1s core levels. The narrowness of these peaks also 266 clearly indicates a surface homogenization of the carbon binding 267

states with the strong decrease or even the vanishing of some high binding energy components related to carbon–oxygen bonds.

270 To deeply analyze the H-NDs spectra, deconvolution of the C1s core level spectra was performed (Fig. 4). For the HPHT H-NDs 271272(Fig. 4a), the two main components located at 284.8 and 285.4 eV can be assigned to C–C sp<sup>3</sup> and CH<sub>x</sub> bonds, respectively [38]. No C–C sp<sup>2</sup> 273contribution has been detected which is usually located at lower 274binding energy compared to C–C sp<sup>3</sup> [37]. At higher binding energies, 275four weaker contributions located at 286, 286.7, 287.9 and 289 eV 276277could be assigned to oxygenated terminations. Similarly, deconvolution of the C1s core level of detonation H-NDs (Fig. 4b) revealed two 278main peaks related to  $C-C sp^3$  and  $CH_x$  bonds and also contributions at 279higher binding energies. A supplementary component located at very 280high binding energies (290.9 eV) is also observed, but without 281chemical significance. However, when XPS analyses were performed 282 on different areas of the samples, the intensity of these high energy 283 contributions (between 286 and 291 eV) fluctuate while those of the 284 main components (C–C sp<sup>3</sup> and  $CH_x$ ) do not change. Moreover, the 285atomic oxygen content calculated from O1s core level remained close 286to 3 at.% whatever the proportion of high energy components in the 287C1s core level . This phenomenon suggests that the components 288located at high binding energies are not related to C/O chemical bonds 289on the NDs, but to an experimental artefact, such as charging effects. 290291 Indeed, compared to the as-received NDs, hydrogenated NDs are

probably highly insulating due to the surface cleaning by the 292 hydrogen plasma. Furthermore their deposition on the sample holder 293 led to the formation of aggregates due to their hydrophobic character. 294 Consequently, charging effect under photon illumination is strongly 295 conceivable on our samples. This charge build-up leads to the 296 deformation of the core levels between 286 and 291 eV, with some 297 difference between HPHT and Detonation NDs probably due to a size 298 effect [26] and an inhomogeneous deposition on the sample holder. 299

To summarize, from FTIR analyses, oxygenated terminations 300 initially present on NDs surface were removed by hydrogenation 301 plasma, including carboxylic and hydroxyl groups. This qualitative 302 analysis points out the hydrogenation efficiency in term of surface 303 homogenization. Additionally, as transmission FTIR probes the whole 304 sample, we have a clear indication that the entire NDs surface has 305 been treated by the MPCVD plasma. Yeap et al. mentioned that 306 hydroxyl groups remain after hydrogenation [24] (from FTIR 307 analysis), but the comparison is difficult because no details about 308 their experimental conditions are given. In our case, XPS analyses 309 confirmed the hydrogenation with quantitative data. The oxygen 311 effect, a severe removal of the C/O components is observed at the C1s 312 core levels. The presence of this small oxygen percentage on the 313 surface has to be discussed. Indeed, the transfer of the H-NDs from the 314

hydrogenation set-up to the XPS spectrometer was fast and carefully 315 316 controlled but a slight exposition to air cannot be avoided leading to a partial re-oxidation of the particles. Additionally, as shown by XPS 317 318 analysis, a weak degradation of the quartz cartridge occurred during exposure to the microwave plasma which may introduce oxygen 319 species in the gas phase during the treatment. In addition to the clear 320 removal of the main oxygenated terminations on H-NDs evidenced by 321 FTIR and XPS, we also have signatures of the hydrogenated 322 323 terminations. After water desorption, FTIR spectra of H-NDs exhibited 324 typically C-H stretching bands of a hydrogenated diamond surface (Fig. 2a). Moreover, XPS analyses showed an important displacement 325of C1s core levels to lower binding energies after treatment, which is 326 in agreement with hydrogenated diamond surfaces [39,40]. For both 327 kinds of H-NDs, C-C sp<sup>3</sup> components were measured at 284.8 eV and 328 this later value is in accordance with binding energies typically 329 measured on undoped hydrogenated diamond thin films [41]. The 330 position and narrowness of this peak is undoubtedly a signature of an 331 efficient surface hydrogenation of both kinds of NDs. 332

Powder X-ray diffraction analyses were performed to study the effect of the hydrogenation on the crystalline structure of the particles. Diffraction patterns are shown in Fig. 5 for HPHT and detonation NDs. All spectra show the characteristic (111) peak of the diamond structure at  $2\theta = 44^{\circ}$ . For both HPHT and detonation NDs, no modification of this peak is observed after hydrogenation. Average

crystallites sizes were calculated from FWHM using Scherrer 339 formula [42] and give a diameter of 16 nm for HPHT NDs and 4 nm 340 for detonation ones. Thus, the size of the diamond core of the NDs is 341 not modified upon hydrogenation, thus confirming that this treat-342 ment is restricted to the NDs surface. 343

#### 3.2. Functionalization

In order to validate the hydrogenation of the NDs, we have 345 investigated their functionalization. As reported for diamond layers, 346 diazonium coupling is known to be very efficient on hydrogenated 347 diamond [21–23]. Therefore, this reaction has been conducted on both 348 as-received and hydrogenated NDs for comparison. Both NDs were 349 then reacted in exactly the same conditions with the nitrobenzene 350 diazonium salt as reported on Fig. 6. Fig. 7a and b show the 351 corresponding FTIR spectra after reaction on HPHT and detonation 352 NDs as well as the one of the nitrobenzene diazonium salt reactant for 353 comparison. 354

FTIR spectrum of the nitrobenzene diazonium shows one stretch- 355 ing vibration band related to the N=N function at 2280 cm<sup>-1</sup>, as well 356 as two intense bands corresponding to the symmetric and antisym- 357 metric ONO stretching vibrations at 1344 and 1520 cm<sup>-1</sup> respectively. 358 After reaction of the HPHT H-NDs with the diazonium salt, the two 359 bands related to the NO<sub>2</sub> group are clearly present at 1344 and 360 1520 cm<sup>-1</sup>, whereas no signal corresponding to the N=N function is  $_{361}$ observed. On the FTIR spectra of as-received NDs, no signature of the 362 ONO stretching vibrations was noticeable, while the CO stretching 363 band at 1775 cm<sup>-1</sup> is still clearly observable. On detonation NDs, 364 signatures of the  $NO_2$  groups are also only observable on previously 365 hydrogenated NDs. XPS analyses performed on HPHT samples 366 revealed a nitrogen atomic concentration of 3.3 at.% for the functio- 367 nalized H-NDs (Fig. 7b), with an unambiguous component at 406 eV 368 related to NO<sub>2</sub> groups on the N1s core level [43] (insert Fig. 7b). Note 369 that no signature of the  $\mathrm{BF_4}^-$  counter-ion was noticed on the XPS  $_{\rm 370}$ spectra confirming the reaction of the diazonium salt. For the as- 371 received NDs, no component around 406 eV was detected and the 372 nitrogen atomic concentration was evaluated at 0.4 at.%. 373

These results evidenced that the spontaneous coupling of the 374 diazonium derivative occurs only on the H-NDs. This reaction is 375 confirmed by the FTIR and XPS signatures of the NO2 groups, but also 376 by the lack of N≡N signal on the FTIR spectrum pointing out the 377 grafting of the nitrobenzene group through a covalent bond. From the 378 3.3 at.% of nitrogen of XPS analysis, we can estimate the surface 379 density of nitrophenyl groups grafted on the NDs between 0.5 and 1 380 function/nm<sup>2</sup>. This value lies in the same range of density reported for 381 functionalized diamond films in similar conditions (3 molecule/nm<sup>2</sup>) 382 corresponding to a densely packed monolayer of nitrophenyl groups 383 [21]. It is important to note that this reaction was conducted on H-NDs 384 only under a vigorous stirring, whereas the grafting of diazonium salts 385 on as-received NDs assisted by ultrasonication has been reported [44]. 386 In the latter case, a lower rate of grafting has been obtained with 387 0.3 at.% of nitrogen for XPS analysis. Our results are consistent with 388 this study and show that spontaneous diazonium coupling is only 389 efficient on hydrogenated NDs suggesting an activated grafting by the 390 hydrogenated surface, as it is reported for hydrogenated diamond thin 391 films. The hydrogenation efficiency of the NDs surface is thus 392 confirmed by this selective functionalization. 393

#### 394 4. Conclusion

This study reports a new approach for NDs hydrogenation conferring hydrogenated terminations to their whole surface. This efficient surface treatment is performed by exposing NDs located in the gas phase to hydrogen microwave plasma. Hydrogenation 398 modified the surface of the NDs without altering their crystalline 399 sp<sup>3</sup> diamond core. This treatment allows the hydrogenation of large 400 amount of NDs of about hundred milligrams. Two kinds of NDs (HPHT 401 and detonation) have been successfully hydrogenated giving rise to 402 similar homogeneous hydrogenated surfaces. FTIR and XPS analyses 403 well evidenced the removal of the oxygenated groups initially present 404 on NDs surface as well as typical signatures of hydrogenated 405 terminations. Hydrogenated NDs exhibit very close spectroscopic 406 characteristics compared to hydrogenated diamond layers especially 407 for the XPS C1s core level. Functionalization of NDs by diazonium 408 coupling has been realised showing spontaneous coupling only on H-409 NDs compared to as-received NDs. This efficient grafting through 410 covalent bonds validates the hydrogenation treatment.

As already mentioned in the Introduction section, hydrogen 412 terminations are known to confer specific physico-chemical proper- 413 ties to diamond surfaces, allowing specific derivatization routes. The 414 latters can be thus applied to hydrogenated nanoparticles opening the 415 route to new strategies for the functionalization of NDs. This is 416 currently under investigation in our laboratories. Moreover, the 417 electronic properties of H-NDs will be studied and compared to 418 hydrogenated films. 419
