Numerical modeling of wave propagation in anisotropic visco-elastic laminated materials in transient regime. Application to modeling ultrasonic testing of composite structures

Abstract

Composite laminate structures remain an important family of materials used in cutting-edge industrial areas. Building efficient numerical modeling tools for high-frequency wave propagation in order to represent ultrasonic testing experiments of these materials remains a major challenge. In particular, incorporating attenuation phenomena within anisotropic plies, and thin intermediate isotropic layers between the plies often represent significant obstacles for standard numerical approaches. In our work, we address both issues by proposing a systematic study of the fully discrete propagators associated to the Kelvin-Voigt, Maxwell and Zener models, and by incorporating effective transmission conditions between plies using the mortar element method. We illustrate the soundness of our approach by proposing intermediate 1D and 2D numerical evidence, and we apply it to a more realistic configuration of a curved laminate composite structure in a 3D setting.

Keywords: visco-elasticity; time integration, explicit; finite element methods; acoustics;

1. Introduction

Ultrasonic Testing (UT) is one of the most popular Non-Destructive Evaluation (NDE) technique used to control industrial components subjected to safety requirements. It has become a major asset in numerous advanced industrial fields, such as nuclear energy industry, petrochemical industry or aeronautics. The principle of traditional UT methods [1] is to use high-frequency acoustic and elastic waves to conduct examinations and make measurements without affecting the structure integrity. Since the industrial materials and structures are reaching high levels of complexity, the associated ultrasonic NDE technologies and diagnosis methods require up-to-date modeling tools. As a consequence, simulation of UT configurations has been identified as a task of paramount importance [2, 3], typically for experimental data analysis [4, 5] or evaluation of control processes [6, 7]. In most practical cases, relevant indications are extracted by performing sensitivity analysis w.r.t. constitutive parameters, requiring a large number of direct simulations. These direct simulations need to encompass a wide range of complex physical mechanisms involved during a UT testing processes has to be taken into account to propose quantitative models of UT inspections. Essentially it entails that direct solvers should address many specific physical behaviors, while providing essential results in a reasonable time.

The development of models fitting these requirements is the subject of numerous contributions. Although it is not the purpose to review them herein, one can at least mention the class of high-frequency asymptotic methods [8, 9, 10], finite difference methods [11], boundary element methods [12], finite element methods in

transient regime [13, 14] or more recent developments such as the Local Interaction Simulation Approach (LISA) [15, 16]. In this communication, the primary focus of our attention is the class of time-domain finite element methods. In order to achieve sufficient performances, a popular approach using finite element methods is to consider dedicated solvers built for specific hardware architectures [17, 18, 19]. Alternatively, authors in [20] have proposed a specific block-structured strategy based upon spectral finite elements and a domain decomposition approach, yielding enhanced performances on standard computers. Initially used locally around a defect to compute the diffracted field and echo response [21] within the CIVA platform [22], this approach has been used in the context of the UT inspection of an entire laminate composite specimen [23, 24].

In the context of time-domain wave propagation modeling within composite materials, one of the main challenges is to incorporate efficiently the attenuation effects in the numerical scheme. These effects are mainly due to the viscosity of the epoxy matrix and the multiple scattering of the incident wave by the reinforcing constituents embedded in this matrix. Also, another challenge associated to the UT of laminates, is the modeling the structural noise inherent to the stratified structure of the material. Usually, this aspect is taken into account by considering thin intermediate layers (with thickness of the order of several microns), much smaller than the characteristic wavelength of the source wave. A typical numerical approach, applied e.g. in [20], is to address this issue by using finite elements with a lower order of approximation in the stratification direction. However, as long as the intermediate layers are meshed, the stability condition on the time step of any explicit time scheme necessarily deteriorates as their thickness decreases. This aspect may potentially leads to substantial computational costs in practical configurations.

Our work is dedicated to proposing relevant numerical strategies in order to address both challenges. In particular, the contributions of our work are twofold:

- We compare fully discrete propagators of standard visco-elastic models of Kelvin-Voigt, Maxwell and Zener [25] obtained after finite element space discretization and explicit time discretization. To do so, we propose a common calibration strategy for these models, applicable in the general case of anisotropic constitutive laws. For each model, we use energy related arguments to derive the stability condition of the fully discrete scheme. In the specific case of the Zener propagator, this approach is identical to the one proposed in [26], however we use a slightly different formulation yielding a more concise proof. From the expression of their stability conditions, we are able to analyze and compare the computational and memory costs of the three discrete propagators. This study enables us to address the question of choosing the relevant visco-elastic model, depending on the specifics of the configuration at hand while considering performance issues.
- In order to efficiently account for the intermediate layers, we adapt the mortar element method [27, 28] to incorporate effective transmission conditions between visco-elastic models. We prove that the stability conditions obtained for each discrete propagators are not modified by the effective parameters of the interphase.

The outline of the paper is as follows. In Section 2 we derive and compare the fully discrete propagators of the visco-elastic models. In Section 3, we study the numerical scheme obtained when using the mortar element method to incorporate effective transmission conditions between visco-elastic propagators. In Section 4 we illustrate our strategy in the context of the UT of curved Carbon Fiber Reinforced Polymer (CFRP) composite structures in a 3D setting. Finally, we give some conclusions and perspectives in Section 5.

2. Comparing fully discrete visco-elastic propagators

In this section we compare fully discrete propagators, i.e. after time and space discretization, of the Kelvin-Voigt, Maxwell and Zener visco-elastic models [25]. First, we start by proposing, for each model, a simple calibration procedure. In essence, this calibration aims at identifying complex stiffness modulii at a frequency of interest, and can be applied to general anisotropic materials. Second, we prove the stability conditions of the explicit time schemes associated to each model using energy arguments. Finally, we derive qualitative comparaison of the computational cost associated to the discrete propagators.

2.1. Identified visco-elastic properties at a central frequency of interest

We are interested in the propagation of high-frequency elastic waves within a given solid material Ω , an open subset of \mathbb{R}^d with $d \in \{1, 2, 3\}$. The waves are typically generated from an input excitation source, e.g. a piezo-electric actuator, usually represented by a boundary load. In most of practical configurations, it is reasonable to assume that this excitation follows a relatively narrow-band signal, with a central angular frequency denoted by ω_{\star} . From a prior theoretical analysis and/or experimental campaign, we assume that it is possible to determine the mechanical material properties of the solid [29]. This characterization may lead to the estimation of the phase velocity and attenuation of incident plane waves, around the frequency of interest and for varying incident angles and polarizations, see for instance [30, 31, 32, 33]. This information enables to identify [34, 35, 36] the elastic and viscous behavior of the material. In the frequency domain, it amounts to obtaining the real and imaginary parts of the stiffness tensor appearing in the constitutive law, locally in the frequency spectrum, i.e. around ω_{\star} . In addition, one may possess an estimation of the dependency of the attenuation w.r.t. the angular frequency, the variation of the phase velocity being sufficiently limited to be neglected in most cases. This aspect is usually leading the choice of the relevant visco-elastic relaxation tensor [37, 25]. Throughout this paper, we will consider exclusively the standard Kelvin-Voigt, Maxwell and Zener models, leading to quadratic, constant and locally linear attenuation laws respectively, see [25] or Appendix A.

The mechanical properties of the material identified at ω_{\star} are: ρ_{\star} the mass density, \mathcal{C}_{\star} and \mathcal{D}_{\star} the real and imaginary parts of the stiffness tensor. They are symmetric and positive definite fourth order tensors, and we assume that they satisfy a "low-loss" assumption

$$Q_{\star} = \mathcal{D}_{\star}^{-1} \mathcal{C}_{\star} > \mathfrak{I}, \tag{1}$$

where \mathcal{I} is the fourth order identity tensor, and \mathcal{Q}_{\star} is referred to as the quality factor of the material [38, 25].

2.2. Generalities on space discretization using lumped finite elements

In this section, we consider visco-elastic formulations written in terms of displacement vector field, or displacement and symmetric stress tensor. In the scope of our work, we restrict ourselves to primal – dual formulations [39]. The displacement variables are sought in $V = [H^1(\Omega)]^d$, and the symmetric stresses tensor variable in $W = [L^2(\Omega)]^{d'}$, with $d' = \frac{1}{2}(d+1)d$. While the construction of a discrete space $W_h \subset W$ is naturally obtained using discontinuous elements, we assume that standard continuous finite elements [40] are used in order to build a H^1 – conform discrete space V_h . Assuming that a conform tessellation \mathcal{T}_h of Ω is given, V_h is defined in the following manner

where \underline{F}_K is the geometric transformation of a reference finite element into the element $K \in \mathcal{T}_h$, and \hat{V}_h is a finite dimensional functional space defined on the reference element. We focus our attention on traditional finite element procedures that consider \hat{V}_h as the space of (potentially high-order) Lagrange polynomials defined on simplexes, e.g. triangles or tetrahedra, or on parallelotopes, e.g. quadrangles or hexahedra. In the following, we will denote by N_h and N'_h the dimensions of V_h and W_h respectively. For any function $\underline{u}_h^* \in V_h$, we denote by $\overline{U}^* \in \mathbb{R}^{N_h}$ the vector regrouping the coefficients of the decomposition of \underline{u}_h^* onto the basis of V_h , idem for any functions in W_h .

In the perspective of applying such Lagrange finite element procedure to a time-domain wave propagation problem, we make the additional assumption that we can find a suitable quadrature formulae that enables consistent mass lumping [41, 42, 14, 43]. Upon this assumption, denoting by α a strictly positive function and by \mathcal{A} a symmetric positive fourth order tensor field, the bilinear forms of the type

are represented in the corresponding discrete spaces $V_h \times V_h$ and $W_h \times W_h$ by strictly positive diagonal matrices, trivially invertible.

2.3. Explicit energy related time discretization

In our work, we focus our attention on proposing explicit time schemes, meaning that, at every time steps, obtaining the next iterate only requires the inversion of one or several diagonal matrices. Generally, this class of time schemes are at best conditionally stable. The stability condition is often referred to as the CFL condition, and in practice it corresponds to an upper bound on the time step. Deriving the stability condition for this class of time discretizations may be performed in several ways. In the scope of the present communication, we will systematically favor the approach based upon discrete energy arguments. This approach, extensively detailed in [14, 43], can be decomposed in the following steps: (1) identify a discrete functional satisfying a conservation or decay property; (2) prove that the functional is an equivalent norm on the discrete solution upon a specific condition on the time step.

As an illustrative example, let us consider the case of inviscid elastodynamics, i.e. $\mathcal{D}_{\star} = 0$. Assuming free surface boundary conditions, the field equations read

where $\underline{\nabla}$ is the vector divergence operator, and $\underline{\varepsilon}(\cdot)$ is the linearized Green-Lagrange tensor. The previous equations are completed with non-zero initial conditions. The weak form of this problem consists in finding, for any time t > 0, the solution $\underline{u} \in V$ such that for any $\underline{u}^* \in V$ we have

The mass bilinear form is defined as in (3) with $\alpha = \rho_{\star}$, and the stiffness bilinear form reads

In this context a popular example of explicit time scheme is the so-called leap-frog scheme

where the mass matrix $\mathbb{M}_{\rho_{\star}}^{V}$ and stiffness matrix $\mathbb{K}_{\mathcal{C}_{\star}}$ are the discrete representations of $\mathbf{m}_{\rho_{\star}}^{V}(\cdot, \cdot)$ and $\mathbf{k}_{\mathcal{C}_{\star}}(\cdot, \cdot)$ on $V_{h} \times V_{h}$. Note that, using the mass lumping technique, the mass matrix is diagonal, leading to a fully explicit time scheme. As a first step for deriving the stability condition, we recall the following standard conservation property, obtained by multiplying (5) by $\frac{1}{2\Delta t}(\overrightarrow{U}^{n+1}-\overrightarrow{U}^{n-1})^{\intercal}$.

Lemma 1. Let $\{\overrightarrow{U}^k\}_{k\geq 0}$ be the solution of (5), then the discrete energy functional

satisfies the following conservation relation

The second step is to find the condition ensuring that the functional (6) is an equivalent norm for the discrete solution of (5). To this goal we recall the popular result [14, 39]:

Theorem 1. Denoting by $r(\cdot)$ the spectral radius of a given matrix, the scheme (5) is stable upon the following condition

Proof. Remarking that,

we can recast the expression of the discrete energy functional (6) in the following manner

$$\mathbf{E}^{n+\frac{1}{2}} = \frac{1}{2} \Big(\frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n}}{\Delta t} \Big)^{\mathsf{T}} \Big(\mathbb{M}_{\rho_{\star}}^{V} - \frac{\Delta t^{2}}{4} \mathbb{K}_{\mathcal{C}_{\star}} \Big) \Big(\frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n}}{\Delta t} \Big) + \frac{1}{2} \Big(\frac{\overrightarrow{U}^{n+1} + \overrightarrow{U}^{n}}{2} \Big)^{\mathsf{T}} \mathbb{K}_{\mathcal{C}_{\star}} \Big(\frac{\overrightarrow{U}^{n+1} + \overrightarrow{U}^{n}}{2} \Big).$$

Hence, upon the condition (8), this functional is positive which necessarily implies the stability of the numerical scheme due to the conservation property (7). \Box

In order to better interpret this stability condition, and in the perspective of the comparative study between the various time schemes detailed in this section, we recall an estimation related to spectral radii as appearing in (8). Using the decomposition of the bilinear forms in (4) on the elements of the tessellation \mathcal{T}_h , and invoking arguments of change of variables from the reference finite element it is possible to prove, see e.g. [39], that

In the previous inequality $\hat{C}(\mathcal{C}_{\star}, \rho_{\star})$ is a constant depending exclusively on the physical parameters, the choice of the reference finite element and the order of the local Lagrange basis functions. Note that, in this context, h is a global upper bound on the size of the elements in \mathcal{T}_h . Using (9), a less sharp stability condition for the numerical scheme (5) reads

and we recover the well-known result that the stability condition of explicit time schemes applied to hyperbolic systems depends linearly on the space step. For the numerical experiments conducted in this communication we use the sharper condition (8), the computations of the spectral radii being performed using a standard power iteration algorithm.

2.4. Kelvin-Voigt model

The Kelvin-Voigt model [25] consists in finding, for any time t > 0, the displacement field $\underline{u} \in V$ satisfying

with given non-zero initial conditions. In (11), C^{kv} and D^{kv} are symmetric positive fourth order tensors. In order to incorporate the mechanical properties, we propose the following calibration lemma.

Lemma 2. Let $(\mathcal{C}_{\star}, \mathcal{D}_{\star}, \rho_{\star})$ be the mechanical properties obtained at a frequency of interest ω_{\star} , we define an appropriate calibration of the Kelvin-Voigt model (11) as

Proof. The rational behind this calibration is quite simple: it amounts to matching the real and imaginary part of the constitutive law at the frequency of interest ω_{\star} . Even though this approach is rather straightforward for the Kelvin-Voigt model, it will require some additional efforts to be extended in the following to the Maxwell and Zener models. From the constitutive law in (11), we obtain

where $\hat{\cdot} = \mathcal{F}(\cdot)$ is the time domain Fourrier transform. Hence, using this relation at ω_{\star} we obtain relations (12).

For any $\underline{u}^* \in V$, the weak formulation associated to (11) reads

where the mass and stiffness bilinear forms are similar to (4). The presence of the dissipative term necessarily implies that any centered time scheme requires solving a linear system at each time step, even if a masslumping technique is applied. Hence, this approach seems hardly reasonable, especially in the perspective of 3D configurations. An alternate approach is to use an uncentered scheme, the most simple example being

This scheme is a first order scheme (whereas (5) is of order two), however it is fully explicit after mass lumping. In order to derive its stability condition, we start by giving the following discrete decay property.

Lemma 3. Denoting by $\|\cdot\|_{\rho}$ the discrete norm associated to \mathbb{M}_{ρ}^{V} and by $\|\cdot\|_{\mathbb{D}^{kv}}$ the (semi)-norm associated to $\mathbb{K}_{\mathbb{D}^{kv}}$, we define the following functionals

$$\begin{aligned} \left\| \mathbf{K}_{\rho}^{n+\frac{1}{2}} &= \frac{1}{2} \left\| \frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n}}{\Delta t} \right\|_{\rho}^{2}, \\ \mathbf{P}_{\mathcal{C}^{kv}}^{n+\frac{1}{2}} &= \frac{1}{2} \left(\overrightarrow{U}^{n+1} \right)^{\mathsf{T}} \mathbb{K}_{\mathcal{C}^{kv}} \overrightarrow{U}^{n}, \\ \mathbf{P}_{\mathcal{D}^{kv}}^{n+\frac{1}{2}} &= \left\| \frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n}}{\Delta t} \right\|_{\mathcal{D}^{kv}}^{2}, \\ \mathbf{D}_{\mathcal{D}^{kv}}^{n} &= \left\| \frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n-1}}{2\Delta t} \right\|_{\mathcal{D}^{kv}}^{2}, \end{aligned}$$

where $\{\overrightarrow{U}^k\}_{k\geq 0}$ are solutions of (14). The energy functional defined as

$$\mathbf{E}_{\rm kv}^{n+\frac{1}{2}} = \mathbf{K}_{\rho}^{n+\frac{1}{2}} + \mathbf{P}_{{\cal C}^{\rm kv}}^{n+\frac{1}{2}} - \frac{\Delta t}{4} \mathbf{P}_{{\cal D}^{\rm kv}}^{n+\frac{1}{2}},\tag{15}$$

satisfies the following decay property

$$\frac{\mathbf{E}_{kv}^{n+\frac{1}{2}} - \mathbf{E}_{kv}^{n-\frac{1}{2}}}{\Delta t} = -\mathbf{D}_{\mathcal{D}^{kv}}^{n} \le 0.$$
(16)

Proof. Multiplying (14) by $\frac{1}{2\Delta t} (\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n-1})^{\intercal}$ we obtain

$$\frac{\mathbf{K}_{\rho}^{n+\frac{1}{2}} - \mathbf{K}_{\rho}^{n-\frac{1}{2}}}{\Delta t} + \frac{\mathbf{P}_{\mathcal{C}^{kv}}^{n+\frac{1}{2}} - \mathbf{P}_{\mathcal{C}^{kv}}^{n-\frac{1}{2}}}{\Delta t} + \left(\frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n-1}}{2\Delta t}\right)^{\mathsf{T}} \mathbb{K}_{\mathcal{D}^{kv}} \left(\frac{\overrightarrow{U}^{n} - \overrightarrow{U}^{n-1}}{\Delta t}\right) = 0.$$
(17)

Introducing an order one estimate of the discrete velocity

$$\overrightarrow{V}^{n+1} = \frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^n}{\Delta t},$$

we can recast the last term of (17) in the following fashion

$$\left(\frac{\overrightarrow{U}^{n+1}-\overrightarrow{U}^{n-1}}{2\Delta t}\right)^{\mathsf{T}}\mathbb{K}_{\mathcal{D}^{\mathsf{kv}}}\left(\frac{\overrightarrow{U}^{n}-\overrightarrow{U}^{n-1}}{\Delta t}\right) = \left(\frac{\overrightarrow{V}^{n+1}+\overrightarrow{V}^{n}}{2}\right)^{\mathsf{T}}\mathbb{K}_{\mathcal{D}^{\mathsf{kv}}}\overrightarrow{V}^{n}.$$

Remarking that

$$\begin{split} \left(\frac{\overrightarrow{V}^{n+1}+\overrightarrow{V}^{n}}{2}\right)^{\mathsf{T}} \mathbb{K}_{\mathcal{D}^{\mathsf{k}\mathsf{v}}} \overrightarrow{V}^{n} &= \left\|\frac{\overrightarrow{V}^{n+1}+\overrightarrow{V}^{n}}{2}\right\|_{\mathcal{D}^{\mathsf{k}\mathsf{v}}}^{2} - \frac{1}{4} \|\overrightarrow{V}^{n+1}\|_{\mathcal{D}^{\mathsf{k}\mathsf{v}}}^{2} + \frac{1}{4} \|\overrightarrow{V}^{n}\|_{\mathcal{D}^{\mathsf{k}\mathsf{v}}}^{2} \\ &= \left\|\frac{\overrightarrow{U}^{n+1}-\overrightarrow{U}^{n-1}}{2\Delta t}\right\|_{\mathcal{D}^{\mathsf{k}\mathsf{v}}}^{2} - \frac{1}{4} \left\|\frac{\overrightarrow{U}^{n+1}-\overrightarrow{U}^{n}}{\Delta t}\right\|_{\mathcal{D}^{\mathsf{k}\mathsf{v}}}^{2} + \frac{1}{4} \left\|\frac{\overrightarrow{U}^{n}-\overrightarrow{U}^{n-1}}{\Delta t}\right\|_{\mathcal{D}^{\mathsf{k}\mathsf{v}}}^{2} \\ &= \mathbf{D}_{\mathcal{D}^{\mathsf{k}\mathsf{v}}}^{n} - \frac{\Delta t}{4} \frac{\mathbf{P}_{\mathcal{D}^{\mathsf{k}\mathsf{v}}}^{n+\frac{1}{2}} - \mathbf{P}_{\mathcal{D}^{\mathsf{k}\mathsf{v}}}^{n-\frac{1}{2}}}{\Delta t}, \end{split}$$

we can transform (17) in order to obtain the expression of the discrete energy defined in (15), yielding the sought decay property. \Box

From the decay property (16) satisfied by the discrete solution, we can derive the following stability condition on the time step.

Theorem 2. Defining $r_{\mathcal{C}^{kv}} = r((\mathbb{M}_{\rho}^{V})^{-1}\mathbb{K}_{\mathcal{C}^{kv}})$ and $r_{\mathcal{D}^{kv}} = r((\mathbb{M}_{\rho}^{V})^{-1}\mathbb{K}_{\mathcal{D}^{kv}})$, the time scheme (14) is stable upon the following condition

$$\frac{\Delta t^2}{4} r_{\mathcal{C}^{kv}} + \frac{\Delta t}{2} r_{\mathcal{D}^{kv}} \le 1, \tag{18}$$

which implies that the time step should satisfy

Proof. We aim at finding the sufficient condition for functional (15) to be an equivalent discrete norm. Using the following relation

where $\|\cdot\|_{\mathcal{C}^{kv}}$ is the (semi)-norm associated to $\mathbb{K}_{\mathcal{C}^{kv}}$, the energy functional reads

$$\mathbf{E}_{kv}^{n+\frac{1}{2}} = \frac{1}{2} \Big(\frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n}}{\Delta t} \Big)^{\mathsf{T}} \Big(\mathbb{M}_{\rho}^{V} - \frac{\Delta t}{2} \mathbb{K}_{\mathcal{D}^{kv}} - \frac{\Delta t^{2}}{4} \mathbb{K}_{\mathcal{C}^{kv}} \Big) \Big(\frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n}}{\Delta t} \Big) + \frac{1}{2} \Big\| \frac{\overrightarrow{U}^{n+1} + \overrightarrow{U}^{n}}{2} \Big\|_{\mathcal{C}^{kv}}^{2} + \frac{1}{2} \Big\|_{\mathcal{C}^{kv}$$

proving that (18) is a necessary condition for its positivity. Computing this only positive root of the second order inequality, we obtain (19). \Box

Using the estimate (9) on the spectral radii and (18), a less sharp, albeit easier to interpret, upper bound on the time step is

where $\hat{C}_{\mathcal{C}^{kv}}$ and $\hat{C}_{\mathcal{D}^{kv}}$ depends only on the material constitutive law, the mass density and the choice of the reference finite element. Hence, the time step required for the numerical scheme (14) to be stable is

asymptotically, i.e. for small values of h, a quadratic function of the space step. This type of stability condition is similar to the one obtained when using explicit time scheme for parabolic systems. It is only natural to find a stability condition of this nature, since one can derive an explicit parabolic scheme satisfied by the velocity unknown when omitting the elastic part of (14). While the sensitivity to the space step is important, another key point of this stability condition is that it appears to depend linearly w.r.t. the quality factor. Indeed, using the definition (12), we have

$$\frac{2h^2}{\widehat{C}_{\mathcal{D}^{\mathrm{kv}}}} = \frac{2h^2\omega_\star}{\widehat{C}_{\mathcal{C}_\star}}C_{\mathfrak{Q}_\star}$$

where $C_{\Omega_{\star}}$ is a constant depending only on the quality factor defined in (1). Note that, the current analysis has been performed with a first-order uncentered scheme for the viscous terms, however one can expect to obtain similar behaviors for higher order uncentered schemes. In practical configurations, these aspect represents a major difficulty since, for a fixed simulation time window, it can lead to significantly more time steps. However, one asset of (14) is that its implementation is very similar to the inviscid case (5) and only requires a second application of the "stiffness-like" matrix $\mathbb{K}_{D^{kv}}$.

2.5. Maxwell model

The Maxwell system [25] are field equations written in terms of displacement and stress. Completed with non-zero initial conditions, it reads

$$\begin{cases} \rho \partial_{tt}^2 \underline{u} - \underline{\nabla} \cdot \underline{\sigma} = 0, & \text{in } \Omega, \\ S^{\text{mx}} \partial_t \underline{\sigma} + \mathcal{H}^{\text{mx}} \underline{\sigma} = \partial_t \underline{\varepsilon}(\underline{u}), & \text{in } \Omega, \\ \underline{\sigma} \cdot \underline{n} = 0, & \text{on } \partial\Omega. \end{cases}$$
(21)

In (21), S^{mx} and \mathcal{H}^{mx} are homogeneous to a compliance tensor and the inverse of a viscosity tensor respectively. In other words, we define \mathcal{C}^{mx} et \mathcal{D}^{mx} two symmetric and positive tensors such that

Lemma 4. Let $(\mathcal{C}_{\star}, \mathcal{D}_{\star}, \rho_{\star})$ be the mechanical properties obtained at a frequency of interest ω_{\star} , we define an appropriate calibration of the Maxwell model (21) and (22) as

Proof. In the frequency domain, the second equation in (21) satisfied by the stress tensor field reads

$$(\mathcal{S}^{\mathrm{mx}} - \frac{i}{\omega}\mathcal{H}^{\mathrm{mx}})\underline{\widehat{\underline{\sigma}}} = \underline{\widehat{\underline{\varepsilon}}},$$

where $\hat{\cdot} = \mathcal{F}(\cdot)$ is the time domain Fourrier transform. Identifying the real and imaginary parts of this constitutive law with the target modulii at the frequency of interest amount to imposing

where \mathcal{I} is the fourth order identity tensor. Hence, we obtain

$$\mathbb{C}_{\star}\mathbb{S}^{\mathrm{mx}} + \frac{1}{\omega_{\star}}\mathcal{D}_{\star}\mathcal{H}^{\mathrm{mx}} = \mathbb{I}, \quad \mathcal{D}_{\star}\mathbb{S}^{\mathrm{mx}} - \frac{1}{\omega_{\star}}\mathbb{C}_{\star}\mathcal{H}^{\mathrm{mx}} = 0.$$

By solving this system we can derive the following expressions

$$S^{\mathrm{mx}} = \left(\mathfrak{C}_{\star} + \mathfrak{D}_{\star} \mathfrak{C}_{\star}^{-1} \mathfrak{D}_{\star} \right)^{-1}, \quad \mathcal{H}^{\mathrm{mx}} = \omega_{\star} \left(\mathfrak{D}_{\star} + \mathfrak{C}_{\star} \mathfrak{D}_{\star}^{-1} \mathfrak{C}_{\star} \right)^{-1},$$

which leads to (23), using the definition (22).

The weak primal – dual formulation associated to the Maxwell model consists in finding, for any time t > 0, the solution $(\underline{u}, \underline{\sigma}) \in V \times W$ such that $\forall (\underline{u}^*, \underline{\sigma}^*) \in V \times W$ we have

where $\mathbf{m}_{\rho}^{V}(\cdot, \cdot)$, $\mathbf{m}_{S^{\mathrm{mx}}}^{W}(\cdot, \cdot)$ and $\mathbf{m}_{\mathcal{H}^{\mathrm{mx}}}^{W}(\cdot, \cdot)$ are defined as in (3), and

$$\mathbf{b}(\underline{\underline{\sigma}}^{\star},\underline{\underline{u}}^{\star}) = \int_{\Omega} \underline{\underline{\sigma}}^{\star} : \underline{\underline{\varepsilon}}(\underline{\underline{u}}^{\star}) \,\mathrm{d}\Omega, \quad \forall (\underline{\underline{u}}^{\star},\underline{\underline{\sigma}}^{\star}) \in V \times W.$$

The corresponding formulation, semi-discretized in space, reads

Inspired from the previous work of [26] carried out for the Zener model, we consider the following scheme

This scheme is of order two, the first equation being centered in t^n , while the second in $t^{n+\frac{1}{2}}$. We can derive a stability condition for this scheme, again using energy arguments.

Lemma 5. Denoting by $\|\cdot\|_{S^{mx}}$ and $\|\cdot\|_{\mathcal{H}^{mx}}$ the discrete norms associated to the matrices $\mathbb{M}^W_{S^{mx}}$ and $\mathbb{M}^W_{\mathcal{H}^{mx}}$ respectively, we define the following functionals

where $\{\overrightarrow{U}^k\}_{k\geq 0}$ and $\{\overrightarrow{\Sigma}^k\}_{k\geq 0}$ are solutions of (26). The energy functional defined as

$$\mathbf{E}_{\mathrm{mx}}^{n+\frac{1}{2}} = \mathbf{K}_{\rho}^{n+\frac{1}{2}} + \mathbf{P}_{\mathrm{Smx}}^{n+\frac{1}{2}} - \frac{\Delta t^2}{4} \mathbf{B}^{n+\frac{1}{2}},\tag{27}$$

satisfies the following decay property

$$\frac{\mathbf{E}_{\mathrm{mx}}^{n+\frac{1}{2}} - \mathbf{E}_{\mathrm{mx}}^{n-\frac{1}{2}}}{\Delta t} = -\mathbf{D}_{\mathcal{H}^{\mathrm{mx}}}^{n} \le 0.$$
(28)

Proof. Multiplying the first relation in (26) by $\frac{1}{2\Delta t} (\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n-1})^{\mathsf{T}}$, we obtain a first conservation relation

$$\frac{\mathbf{K}_{\rho}^{n+\frac{1}{2}} - \mathbf{K}_{\rho}^{n-\frac{1}{2}}}{\Delta t} + \left(\frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n-1}}{2\Delta t}\right)^{\mathsf{T}} \mathbb{B}^{\mathsf{T}} \overrightarrow{\Sigma}^{n} = 0.$$
(29)

In order to obtain an equivalent expression of the second term, we multiply the second relation in (26) by $\frac{1}{2}(\overrightarrow{\Sigma}^{n+1} + \overrightarrow{\Sigma}^n)^{\intercal}$, leading to

Computing the average of this last relation at times $t^{n+1/2}$ and $t^{n-1/2}$ yields

Following the recombination given in [44], we can extract the following expression

$$-\frac{1}{2} \Big(\frac{\overrightarrow{\Sigma}^{n+1} + \overrightarrow{\Sigma}^{n}}{2} \Big)^{\mathsf{T}} \mathbb{B} \Big(\frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n}}{\Delta t} \Big) - \frac{1}{2} \Big(\frac{\overrightarrow{\Sigma}^{n} + \overrightarrow{\Sigma}^{n-1}}{2} \Big)^{\mathsf{T}} \mathbb{B} \Big(\frac{\overrightarrow{U}^{n} - \overrightarrow{U}^{n-1}}{\Delta t} \Big) = \\ - \Big(\frac{\overrightarrow{\Sigma}^{n+1} - \overrightarrow{\Sigma}^{n}}{2} \Big)^{\mathsf{T}} \mathbb{B} \Big(\frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n}}{2\Delta t} \Big) + \Big(\frac{\overrightarrow{\Sigma}^{n} - \overrightarrow{\Sigma}^{n-1}}{2} \Big)^{\mathsf{T}} \mathbb{B} \Big(\frac{\overrightarrow{U}^{n} - \overrightarrow{U}^{n-1}}{2\Delta t} \Big) \\ - \Big(\overrightarrow{\Sigma}^{n} \Big)^{\mathsf{T}} \mathbb{B} \Big(\frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n-1}}{2\Delta t} \Big),$$
(30)

which leads to

$$\Big(\frac{\overrightarrow{U}^{n+1}-\overrightarrow{U}^{n-1}}{2\Delta t}\Big)^{\mathsf{T}}\mathbb{B}^{\mathsf{T}}\overrightarrow{\Sigma}^{n} = \frac{1}{\Delta t}\Big(\mathbf{P}_{\mathbb{S}^{\mathrm{mx}}}^{n+\frac{1}{2}} - \mathbf{P}_{\mathbb{S}^{\mathrm{mx}}}^{n-\frac{1}{2}}\Big) + \mathbf{D}_{\mathcal{H}^{\mathrm{mx}}}^{n} - \frac{\Delta t}{4}\Big(\mathbf{B}^{n+\frac{1}{2}} - \mathbf{B}^{n-\frac{1}{2}}\Big).$$

Finally, we conclude by combining the previous relation with (29).

As for the previous case of the Kelvin-Voigt model, a stability condition for the numerical scheme (26) is obtained by deriving the condition for the energy functional (27) to be a positive functional.

Theorem 3. Defining the following stiffness matrix

the time discrete scheme (26) is stable upon the following condition

$$\Delta t \le \overline{\Delta t}^{\mathrm{mx}} = \frac{2}{\sqrt{r\left((\mathbb{M}_{\rho}^{V})^{-1}\mathbb{K}_{\mathcal{C}^{\mathrm{mx}}}\right)}}.$$
(32)

Proof. To start with, we use the following relation

$$\mathbf{P}_{\mathcal{S}^{\mathrm{mx}}}^{n+\frac{1}{2}} = \frac{1}{8} \left(\|\overrightarrow{\Sigma}^{n+1} + \overrightarrow{\Sigma}^{n}\|_{\mathcal{S}^{\mathrm{mx}}}^{2} + \|\overrightarrow{\Sigma}^{n+1} - \overrightarrow{\Sigma}^{n}\|_{\mathcal{S}^{\mathrm{mx}}}^{2} \right) = \frac{1}{2} \left\| \frac{\overrightarrow{\Sigma}^{n+1} + \overrightarrow{\Sigma}^{n}}{2} \right\|_{\mathcal{S}^{\mathrm{mx}}}^{2} + \frac{\Delta t^{2}}{8} \left\| \frac{\overrightarrow{\Sigma}^{n+1} - \overrightarrow{\Sigma}^{n}}{\Delta t} \right\|_{\mathcal{S}^{\mathrm{mx}}}^{2}, \quad (33)$$

in order to separate the energy functional (27) in the following manner

$$\mathbf{E}^{n+\frac{1}{2}} = \frac{1}{2} \left\| \frac{\overrightarrow{\Sigma}^{n+1} + \overrightarrow{\Sigma}^n}{2} \right\|_{\mathcal{S}^{\mathrm{mx}}}^2 + \widetilde{\mathbf{E}}^{n+\frac{1}{2}},$$

where

$$\widetilde{\mathbf{E}}^{n+\frac{1}{2}} = \mathbf{K}_{\rho}^{n+\frac{1}{2}} + \frac{\Delta t^2}{8} \left\| \frac{\overrightarrow{\Sigma}^{n+1} - \overrightarrow{\Sigma}^n}{\Delta t} \right\|_{\mathcal{S}^{\mathrm{mx}}}^2 - \frac{\Delta t^2}{4} \mathbf{B}^{n+\frac{1}{2}}.$$

Note that the first term is a positive term and that the second term can be written in the following form

$$\begin{split} \widetilde{\mathbf{E}}^{n+\frac{1}{2}} &= \mathbf{K}_{\rho}^{n+\frac{1}{2}} \\ &+ \frac{\Delta t^2}{8} \left(\left\| \frac{\overrightarrow{\Sigma}^{n+1} - \overrightarrow{\Sigma}^n}{\Delta t} \right\|_{g_{\text{mx}}}^2 - 2 \left(\frac{\overrightarrow{\Sigma}^{n+1} - \overrightarrow{\Sigma}^n}{\Delta t} \right)^{\mathsf{T}} \mathbb{B} \left(\frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^n}{\Delta t} \right) + \left\| \frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^n}{\Delta t} \right\|_{e^{\text{mx}}}^2 \right) \\ &- \frac{\Delta t^2}{8} \left\| \frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^n}{\Delta t} \right\|_{e^{\text{mx}}}^2, \end{split}$$

where $\|\cdot\|_{\mathcal{C}^{mx}}$ is the discrete (semi)-norm associated to the matrix $\mathbb{K}_{\mathcal{C}^{mx}}$. We use the definition (31) of $\mathbb{K}_{\mathcal{C}^{mx}}$ and the square of binomials in order to rewrite the previous expression as

$$\begin{split} \widetilde{\mathbf{E}}^{n+\frac{1}{2}} &= \frac{1}{2} \Big(\frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n}}{\Delta t} \Big)^{\mathsf{T}} \Big(\mathbb{M}_{\rho}^{V} - \frac{\Delta t^{2}}{4} \mathbb{K}_{\mathbb{C}^{\mathrm{mx}}} \Big) \Big(\frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n}}{\Delta t} \Big) \\ &\quad + \frac{\Delta t^{2}}{8} \Big\| \big(\mathbb{M}_{\mathrm{S}^{\mathrm{mx}}}^{W} \big)^{\frac{1}{2}} \Big(\frac{\overrightarrow{\Sigma}^{n+1} - \overrightarrow{\Sigma}^{n}}{\Delta t} \Big) - \big(\mathbb{M}_{\mathrm{S}^{\mathrm{mx}}}^{W} \big)^{-\frac{1}{2}} \mathbb{B} \Big(\frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n}}{\Delta t} \Big) \Big\|_{N_{h}^{\prime}}^{2}, \end{split}$$

where $\|\cdot\|_{N'_h}$ is the Euclidian norm in $\mathbb{R}^{N'_h}$. Hence, the energy function is a positive function under the sought condition on the time step.

Using the estimate (9), we can verify that the stability condition obtained for the Maxwell model varies linearly with the space step, as for the inviscid case (10). Additionally, using the calibration (23), one can remark that

$$\mathcal{C}^{\mathrm{mx}} = \mathcal{C}_{\star} \Big(\mathcal{I} + \mathcal{Q}_{\star}^{-2} \Big).$$

Hence, from the estimate on the spactral radii (9), the time step related to the Maxwell discrete propagator behaves as

$$\overline{\Delta t}^{\mathrm{mx}} = O\left(\left(\mathcal{I} + \mathcal{Q}_{\star}^{-2}\right)^{-\frac{1}{2}}\right),\,$$

so that the difference compared to the inviscid case is limited in a low-loss context. In terms of computational cost, the major computational load in (26) consists in applying \mathbb{B} and \mathbb{B}^{\intercal} at every time steps, which is roughly equivalent to the application of a single stiffness matrix. In this regards, the computational cost required in order to obtain the next iterate in the Maxwell scheme is similar to the inviscid case. It requires however the storage of the stress unknowns in addition to the displacement unknowns, thus increasing its memory load.

2.6. Zener model

The Zener model [25, 26] is defined in terms of displacement and stress unknowns, satisfying the following field equations

$$\begin{cases} \rho \partial_{tt}^{2} \underline{u} - \underline{\nabla} \cdot \underline{\sigma} = 0, & \text{in } \Omega, \\ \underline{\sigma} + \tau^{\text{zn}} \partial_{t} \underline{\sigma} = \mathcal{C}^{\text{zn}} \underline{\varepsilon}(\underline{u}) + \tau^{\text{zn}} \mathcal{D}^{\text{zn}} \partial_{t} \underline{\varepsilon}(\underline{u}), & \text{in } \Omega, \\ \underline{\sigma} \cdot \underline{n} = 0, & \text{on } \partial\Omega, \end{cases}$$
(34)

completed with non-zero initial conditions. In (34), \mathbb{C}^{zn} et \mathcal{D}^{zn} are symmetric positive fourth order tensors representing elasticity and viscosity respectively. The parameter $\tau^{\text{zn}} > 0$ corresponds to a relaxation time of the Zener model [25].

Lemma 6. Let $(\mathcal{C}_{\star}, \mathcal{D}_{\star}, \rho_{\star})$ be the mechanical properties obtained at a frequency of interest ω_{\star} , we define a suitable calibration of the Zener model (34) as

$$\tau^{\mathrm{zn}} = \frac{1}{\omega_{\star}}, \quad \mathcal{C}^{\mathrm{zn}} = \mathcal{C}_{\star} - \mathcal{D}_{\star}, \quad \mathcal{D}^{\mathrm{zn}} = \mathcal{C}_{\star} + \mathcal{D}_{\star}, \quad \rho = \rho_{\star}.$$
(35)

Proof. Applying the Fourier transform in time domain to the second equation in (34) we obtain

$$(1+i\omega\tau^{\mathrm{zn}})\underline{\widehat{\underline{\sigma}}}(\omega) = (\mathcal{C}^{\mathrm{zn}}+i\omega\tau^{\mathrm{zn}}\mathcal{D}^{\mathrm{zn}})\underline{\widehat{\underline{\varepsilon}}}(\omega),$$

or, equivalently,

$$(1+(\omega\tau^{\mathrm{zn}})^2)\underline{\widehat{g}}(\omega) = \left\{ \left(\mathbb{C}^{\mathrm{zn}} + (\omega\tau^{\mathrm{zn}})^2 \mathbb{D}^{\mathrm{zn}} \right) + i\omega\tau^{\mathrm{zn}} \left(\mathbb{D}^{\mathrm{zn}} - \mathbb{C}^{\mathrm{zn}} \right) \right\} \underline{\widehat{g}}(\omega).$$

Thus, choosing $\tau^{\mathrm{zn}} = \omega_{\star}^{-1}$ yields

$$\underline{\underline{\widehat{\sigma}}}(\omega_{\star}) = \left\{ \frac{1}{2} \left(\mathbb{C}^{\mathrm{zn}} + \mathbb{D}^{\mathrm{zn}} \right) + \frac{i}{2} \left(\mathbb{D}^{\mathrm{zn}} - \mathbb{C}^{\mathrm{zn}} \right) \right\} \underline{\underline{\widehat{\varepsilon}}}(\omega_{\star}).$$

Identifying the real and imaginary parts with the target elasticity and viscosity tensors we obtain the following pair of relations

$$\mathfrak{C}^{\mathrm{zn}} + \mathfrak{D}^{\mathrm{zn}} = 2\mathfrak{C}_{\star}, \quad \mathfrak{D}^{\mathrm{zn}} - \mathfrak{C}^{\mathrm{zn}} = 2\mathfrak{D}_{\star},$$

leading to the calibration result (35).

Note that, upon the low-loss assumption (1), one can verify that the tensor C^{2n} expressed in (35) is a positive tensor. Furthermore, the tensor $\mathcal{D}^{2n} - \mathcal{C}^{2n}$ is also positive. This condition has been identified in [26] as a necessary condition in order to ensure the well-posedness of the Zener model. As in [26] we introduce an internal variable $\underline{s} \in W$ defined as the purely viscous part of the stress tensor, namely

The Zener model written in terms of displacement and internal variable reads

$$\begin{cases} \rho \partial_{tt}^{2} \underline{u} - \underline{\nabla} \cdot \left(\mathbb{C}^{\mathtt{zn}} \underline{\underline{\varepsilon}}(\underline{u}) \right) - \underline{\nabla} \cdot \underline{\underline{s}} = 0, & \text{in } \Omega, \\ \mathcal{E}^{\mathtt{zn}} \partial_{t} \underline{\underline{s}} + \mathcal{E}_{\tau}^{\mathtt{zn}} \underline{\underline{s}} - \partial_{t} \underline{\underline{\varepsilon}}(\underline{u}) = 0, & \text{in } \Omega, \\ \underline{\sigma} \cdot \underline{n} = 0, & \text{on } \partial \Omega. \end{cases}$$
(37)

where \mathcal{E}^{zn} and $\mathcal{E}^{\text{zn}}_{\tau}$ are two symmetric positive tensors such that

$$\mathcal{E}^{\mathrm{zn}} = \left(\mathcal{D}^{\mathrm{zn}} - \mathcal{C}^{\mathrm{zn}}\right)^{-1}, \quad \mathcal{E}^{\mathrm{zn}}_{\tau} = \frac{1}{\tau^{\mathrm{zn}}} \mathcal{E}^{\mathrm{zn}}.$$
(38)

Hence, the weak primal-dual formulation associated to the Zener model consists in finding, for any time t > 0, the solution $(\underline{u}, \underline{\underline{s}}) \in V \times W$ such that $\forall (\underline{u}^*, \underline{\underline{s}}^*) \in V \times W$ we have

$$\begin{cases} \frac{\mathrm{d}^2}{\mathrm{d}t^2} \mathbf{m}_{\rho}^V(\underline{u},\underline{u}^*) + \mathbf{k}_{\mathcal{C}^{\mathrm{zn}}}(\underline{u},\underline{u}^*) + \mathbf{b}(\underline{\underline{s}},\underline{u}^*) = 0, \\ \frac{\mathrm{d}}{\mathrm{d}t} \mathbf{m}_{\mathcal{E}^{\mathrm{zn}}}^W(\underline{\underline{s}},\underline{\underline{s}}^*) + \mathbf{m}_{\mathcal{E}^{\mathrm{zn}}_{\tau}}^W(\underline{\underline{s}},\underline{\underline{s}}^*) - \frac{\mathrm{d}}{\mathrm{d}t} \mathbf{b}(\underline{\underline{s}}^*,\underline{u}) = 0, \end{cases}$$

where $\mathbf{m}_{\rho}^{V}(\cdot, \cdot)$, $\mathbf{m}_{\mathcal{E}^{zn}}^{W}(\cdot, \cdot)$, and $\mathbf{m}_{\mathcal{E}^{zn}_{\tau}}^{W}(\cdot, \cdot)$ are defined as in (3), $\mathbf{k}_{\mathcal{C}^{zn}}(\cdot, \cdot)$ is defined as in (4), and $\mathbf{b}(\cdot, \cdot)$ is defined in (25). As for the Maxwell model, and also inspired from [26], we consider the following time scheme

$$\begin{cases} \mathbb{M}_{\rho}^{V} \frac{\overrightarrow{U}^{n+1} - 2\overrightarrow{U}^{n} + \overrightarrow{U}^{n-1}}{\Delta t^{2}} + \mathbb{K}_{\mathbb{C}^{2n}} \overrightarrow{U}^{n} + \mathbb{B}^{\mathsf{T}} \overrightarrow{S}^{n} = 0, \\ \mathbb{M}_{\mathcal{E}^{2n}}^{W} \frac{\overrightarrow{S}^{n+1} - \overrightarrow{S}^{n}}{\Delta t} + \mathbb{M}_{\mathcal{E}^{2n}_{\tau}}^{W} \frac{\overrightarrow{S}^{n+1} + \overrightarrow{S}^{n}}{2} - \mathbb{B} \frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n}}{\Delta t} = 0. \end{cases}$$
(39)

It is a second order scheme, the first and second equation being centered in t^n and $t^{n+\frac{1}{2}}$ respectively. As previously, we start by giving a first result of discrete energy decay in order to derive in a second step the stability condition associated to (39).

Theorem 4. Denoting by $\|\cdot\|_{\mathcal{E}^{2n}}$ and $\|\cdot\|_{\mathcal{E}^{2n}_{\tau}}$ the discrete norms associated to the matrices $\mathbb{M}^W_{\mathcal{E}^{2n}_{\tau}}$ and $\mathbb{M}^W_{\mathcal{E}^{2n}_{\tau}}$ respectively, we define the following functionals

$$\begin{aligned} \left| \mathbf{K}_{\rho}^{n+\frac{1}{2}} &= \frac{1}{2} \left\| \frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n}}{\Delta t} \right\|_{\rho}^{2}, \\ \mathbf{P}_{\mathcal{C}^{n+\frac{1}{2}}}^{n+\frac{1}{2}} &= \frac{1}{2} (\overrightarrow{U}^{n+1})^{\mathsf{T}} \mathbb{K}_{\mathcal{C}^{2n}} \overrightarrow{U}^{n}, \\ \mathbf{P}_{\mathcal{E}^{2n}}^{n+\frac{1}{2}} &= \frac{1}{4} \left(\| \overrightarrow{S}^{n+1} \|_{\mathcal{E}^{2n}}^{2} + \| \overrightarrow{S}^{n} \|_{\mathcal{E}^{2n}}^{2} \right), \end{aligned}$$

$$\begin{aligned} \mathbf{B}^{n+\frac{1}{2}} &= \left(\frac{\overrightarrow{S}^{n+1} - \overrightarrow{S}^{n}}{\Delta t} \right)^{\mathsf{T}} \mathbb{B} \left(\frac{\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n}}{\Delta t} \right), \\ \mathbf{D}_{\mathcal{E}^{n+\frac{1}{2}}}^{n} &= \frac{1}{2} \left\| \frac{\overrightarrow{S}^{n+1} + \overrightarrow{S}^{n}}{2} \right\|_{\mathcal{E}^{n+\frac{1}{2}}}^{2} + \frac{1}{2} \left\| \frac{\overrightarrow{S}^{n} + \overrightarrow{S}^{n-1}}{2} \right\|_{\mathcal{E}^{2n}}^{2}, \end{aligned}$$

where $\{\overrightarrow{U}^k\}_{k\geq 0}$ and $\{\overrightarrow{S}^k\}_{k\geq 0}$ are solutions of (39). The energy functional defined as

$$\mathbf{E}_{zn}^{n+\frac{1}{2}} = \mathbf{K}_{\rho}^{n+\frac{1}{2}} + \mathbf{P}_{\mathcal{C}^{zn}}^{n+\frac{1}{2}} + \mathbf{P}_{\mathcal{E}^{zn}}^{n+\frac{1}{2}} - \frac{\Delta t^2}{4} \mathbf{B}^{n+\frac{1}{2}},\tag{41}$$

satisfies the following identity

$$\frac{\mathbf{E}_{zn}^{n+\frac{1}{2}} - \mathbf{E}_{zn}^{n-\frac{1}{2}}}{\Delta t} = -\mathbf{D}_{\mathcal{E}_{\tau}^{zn}}^{n} \le 0.$$
(42)

Proof. Multiplying the first relation in (39) by $\frac{1}{2\Delta t} (\overrightarrow{U}^{n+1} - \overrightarrow{U}^{n-1})^{\intercal}$ yields

After multiplication of the second relation of (39) by $\frac{1}{2}(\vec{S}^{n+1}+\vec{S}^n)^{\intercal}$, we compute the mean values obtained at times $t^{n+1/2}$ and $t^{n-1/2}$, then, using the identity (30) (with replacement of the stress unknown by the internal variable unknown), we obtain

which, combined with (43), leads to the relation (42).

Note that, even though its proof differs, the previous result is identical to Theorem 4.1 of [26]. Using this energy identity we can deduce the following stability result.

$$\Delta t \le \overline{\Delta t}^{\mathrm{zn}} = \frac{2}{\sqrt{r\left((\mathbb{M}_{\rho}^{V})^{-1}\mathbb{K}_{\mathcal{D}^{\mathrm{zn}}}\right)}}.$$
(45)

Proof. Replacing stress unknowns by internal variables unknowns in relation (33) in order to re-formulate $\mathbf{P}_{g^{zn}}^{n+\frac{1}{2}}$, the functional (41) is decomposed into

such that

We use the square of binomials in order to recast the second term in the previous expression into

Finally, using the relation (20) applied to $\mathbf{P}_{\mathbb{C}^{2n}}^{n+\frac{1}{2}}$, we obtain

where $\|\cdot\|_{\mathcal{C}^{2n}}$ stands for the (semi)-norm associated to $\mathbb{K}_{\mathcal{C}^{2n}}$. Hence, the discrete energy is positive under the condition (45).

Using the estimate (9), we can verify that the stability condition obtained for the Zener model varies linearly with the space step, as for the Maxwell case and inviscid case. Additionally, using the calibration (35), one can remark that

While the effect of the viscosity on the time step is expected to be limited in a low-loss context, it is interesting to remark that the Zener discrete propagator appears to be more sensitive to the viscosity compared to the Maxwell case. Additionally, note that the main part of the computation load in (39) comes from the application of $\mathbb{K}_{\mathbb{C}^{2n}}$, \mathbb{B} and \mathbb{B}^{\intercal} at every time steps. This corresponds roughly to the application of two stiffness-like matrices. Hence, the computation of a next iterate in the Zener scheme is similar to the

Kelvin-Voigt case, and is two times more expensive than the Maxwell and the inviscid case. However, the memory load required for (39) is similar to the Maxwell discrete scheme.

In Table 1 we propose to summarize various characteristics of each fully discrete propagators. As a direct consequence, for a given set of target mechanical properties, one can expect to have the following relation between the stability conditions

As expected, these stability conditions are identical when $\mathcal{D}_{\star} = 0$. Note that, in the specific case of $\mathfrak{Q}_{\star} = \mathfrak{I}$, we should expect to have $\overline{\Delta t}^{mx} = \overline{\Delta t}^{zn}$.

2.7. Numerical illustration on a one-dimensional configuration

The goal of this section is twofold. First we provide numerical evidence of the specific behaviors, detailed in Table 1, of the stability conditions of the numerical schemes. Second, we illustrate how the numerical schemes can adequatly represent the various characteristics of the Kelvin-Voigt, Maxwell and Zener models in terms of attenuation laws and phase velocities. For the latter item, we wish to rely on comparisons with analytical results, and to do so we restrict ourselves to the one-dimensional case.


Let us consider the following domain $\Omega =]0; L[$, with L = 30 mm. We set the frequency of interest to $f_{\star} = 4$ MHz, with $\omega_{\star} = 2\pi f_{\star}$, the mass density to $\rho_{\star} = 8$ g · cm⁻³, and the target elasticity modulus to $C_{\star} = 288$ GPa. The velocity of waves in the inviscid case is set to $v_P = 6$ mm · μs^{-1} , which roughly corresponds to the velocity of longitudinal bulk waves in steel materials.

Sensitivity of the stability conditions w.r.t. space discretization and quality factor. In Figure 1a, the mesh step is set to h = 0.1 mm, and we use polynomials of order 5 within each elements. We allow the target imaginary part of the stiffness coefficient to vary in the interval $D_{\star} \in [10 \text{ GPa}; 288 \text{ GPa}]$. For each values we plot the associated CFL conditions in log scale. We clearly observe that the hierarchy (46) between the time steps is respected. The CFL conditions in the inviscid, Maxwell and Zener cases are close to each other, while the ones associated to the Kelvin-Voigt propagator are significantly lower and following a linear tendency as expected. Note that, in the particular case of $\Omega_{\star} = J$, one can verify that $\overline{\Delta t}^{mx} = \overline{\Delta t}^{zn}$.

In Figure 1b, the target imaginary part is set to $D_{\star} = 10$ GPa, the mesh step varies in the interval [0.015; 0.1] mm, and for each values we plot in log scale the stability conditions of each propagators. We can clearly observe the linear behaviors in the inviscid, Maxwell and Zener cases, while the Kelvin-Voigt CFL conditions follow a quadratic dependency.

Attenuation laws and phase velocities. In the context of one-dimensional visco-elastic propagation models, we denote by $k \in \mathbb{C}$ a complex wave number related to a monochromatic one-dimensional plane wave. We decompose $k = \kappa - i\alpha$, so that α is directing the attenuation of the plane waves. The dependency of α w.r.t. to the angular frequency $\omega \in \mathbb{R}^+$ is referred to as the attenuation law of the visco-elastic model. In the following, we propose to evaluate numerically these attenuation laws for each discrete propagators, along with the phase velocities.

To do so, we set the target viscosity to $D_{\star} = 10$ GPa. We impose the solution at x = 0 to be a wide-band signal, typically a Ricker's wavelet, centered in the frequency domain at ω_{\star} . At x = L, we use absorbing boundary conditions to avoid undesired reflections.




Figure 2: Comparing attenuation laws and phase velocities obtained from the fully discrete propagator of the Kelvin-Voigt,

By performing a Fourier analysis of the numerical solution at an observation point, set to x = L/2, we are able to evaluate the "numerical" attenuation law obtained from the various fully discrete propagators. Using the expression of the exact attenuation law provided in (A.2), we compare in Figure 2a the expected attenuation (in solid, dashed and dotted lines) with the numerical ones (in square markers). A first remark is that the curves for the three visco-elastic models intersect exactly at the frequency of interest, proving the validity of our calibration procedure. Second, we have an excellent agreement between the expected and the numerical attenuation laws, validating the consistency of our complete numerical procedure with respect to the continuous equations. Indeed we are able to reproduce the quadratic, constant and locally linear attenuation law corresponding to the Kelvin-Voigt, Maxwell and Zener, as recalled in Appendix A.

In the same way, we recover the phase velocity of the discrete propagators. In Figure 2b, we compare the dispersion curves obtained numerically with the exact dispersion curves using the expression of the exact phase velocities for visco-elastic models provided in (A.2). We remark that the limited dispersion of the discrete propagators is in very good agreement with the theoretical ones and coincide at the frequency of interest. However, we should point out the specific case of the Kelvin-Voigt propagator that appears to incorporate spurious numerical dispersion at high frequencies, most likely due to the fact that it is a first order time scheme.

2.8. Choosing the relevant visco-elastic propagator

To the best of the authors' knowledge, a popular choice of visco-elastic model is the Kelvin-Voigt model (11). A possible explanation for this tendency is the rather simple form of the constitutive law, yielding a direct link with the complex stiffness coefficients obtained from the material characterization. Note that this direct link clearly appears in the straightforward calibration given in (12). Another potential argument that may explain the popularity of the Kelvin-Voigt model is its simplicity of implementation. In practice, it simply amounts to applying a second stiffness operator, usually already implemented for performing iterations of the inviscid model (5). Nonetheless, the detailed analysis proposed in this section has shed light to significant issues related to the computational performances of the Kelvin-Voigt fully-discrete propagator. Hence, as a conclusion of this section, we discuss the rational for choosing the relevant visco-elastic model for a given configuration.

An important discriminant characteristic of the visco-elastic models is their related attenuation law, as depicted in Figure 2a. For the Zener and Kelvin-Voigt model, the attenuation grows respectively as a (locally) linear and a quadratic function of the frequency. As a consequence, this particular aspect may entail a shift of the ultrasonic wave field towards lower frequencies. We show a concrete example of this effect in the Figure 10a of the final result Section 4. These shifts may become more visible as the distance of propagation increases, or equivalently as as the quality factor decreases. Hence, if the main expected results of the numerical modelling is related to the spectral content of the outputs, then the choice of the visco-elastic model should be driven by its attenuation law.

Otherwise, a more practical argument may be used. At this point, it is important to emphasize that, by construction, the calibration procedure proposed in this section ensures that the three models recover an identical attenuation at the frequency of interest. Hence, assuming that it is sufficient, one can choose the visco-elastic model depending on the performances associated to the fully-discrete scheme. In this regard, we refer to Table 1 to infer a strict hierarchy between propagators. With its low dependency of the CFL condition w.r.t. the quality factor, and with only one stiffness operation per time step, the Maxwell propagator (26) is nearly as effective as the inviscid propagator (5). The Zener propagator also exhibits a robust CFL condition w.r.t. the quality factor. However, it costs another stiffness operation, yielding roughly a doubled iteration cost compared to the Maxwell propagator. Similarly, the Kelvin-Voigt model presents two stiffness operations per time step. More importantly, Figure 1a and Figure 1b illustrates the strong sensitivity of its CFL condition w.r.t. the quality factor and the mesh step. Hence, the timestep of the Kelvin-Voigt model can be in practice significantly smaller, leading to an increase number of iterations to reach a fixed final time. Due to the explicit uncentered treatment of the viscous term in (14), we have obtained a first-order time scheme. Thus, in addition to its cost, the Kelvin-Voigt propagator may lead to less accurate results in some cases. This hierarchy, illustrated in a practical case of 3D computations in the Tables 3, 4 and 5, clearly suggests that, if the choice if the visco-elastic propagtor is driven by computational performances, the best choice is the Maxwell model.

3. Fully discrete propagators of anisotropic visco-elastic laminated materials

The goal of this section is to detail a fully discrete propagator for a class of laminated materials. In each layer (or ply) of the laminate we assume that the material follows an anisotropic visco-elastic constitutive law. Between each pair of plies, we consider thin intermediate layers of visco-elastic materials. In practice, these intermediate layers play an important roles in the modeling of laminated structures, since they can be used to represent structural noise or specific bonding conditions between plies.

From a computational standpoint, addressing this type of configurations is challenging, especially in a 3D context. Apart from the construction of the visco-elastic discrete propagators for the plies, subject treated in the previous section, one of the main difficulty is the efficient incorporation of the thin intermediate layers within the numerical solver. A reasonable approach, proposed for instance in [20], is to use finite elements with anisotropic orders to limit the cost overhead.

In the scope of our work, we focus our attention on an alternate approach based upon Effective Transmission Conditions (ETCs) [45, 46, 47]. In this context, the effect of a thin intermediate layer (or interphase) is taken into account through so-called spring-mass conditions. In practice, this approach circumvent the difficulty of meshing the interphase medium, potentially yielding significant improvements in computational costs. The key points of this section are:

- After recalling the standard elements of ETCs and their calibration w.r.t. the target complex stiffness modulii, we show how they can be incorporated to visco-elastic discrete propagators using the mortar element method [27, 28],
- We prove that the incorporation of these ETCs does not affect the stability condition computed (independently) for each ply. In particular, this condition on the time step does not depend on the material properties of the interphase.

To simplify the presentation of the coupling scheme obtained from the mortar element method, we consider the specific case of two plies sharing one interphase, and we assume that each plies support a Zener formulation (34). The extensions to Kelvin-Voigt or Maxwell models with multiple intermediate layers are straightforward.

3.1. Definition of a class of laminated configurations

Plane and curved geometry of a laminate material. Let $\{\underline{e}_i\}_{k=1}^d$ be the canonical basis of \mathbb{R}^d . We denote by Ω° an open bounded subset of \mathbb{R}^d representing the solid under study, and we assume that there exists a set of strictly positive values $\{L_i\}_{i=1}^d$ such that

Let \underline{e}_d be the stratification direction, we consider a decomposition of Ω° into two plies Ω_1° and Ω_2° , of thicknesses ℓ_1° and ℓ_2° respectively. Between these two plies, we define an intermediate layers $\Omega^{\circ,\eta}$ of thickness $\ell^{\circ,\eta}$. The domain Ω° is the non-overlapping union of the plies and the intermediate layer

In practical cases, the material at hand has a curved geometry. This geometry is usually obtained during manufacturing processes by deformation of a plane geometry. A convenient way to model these configurations is to consider a given mapping $\underline{\Phi}$, yielding the resulting geometries

In order to ensure a geometry suitable for standard numerical procedures, we make some regularity assumption on this transformation. In particular, we assume that $\underline{\Phi}$ is a diffeomorphism, i.e. it is a differentiable bijection and its inverse is also differentiable, and that $\underline{\Phi}$ is a conformal map, i.e. it locally preserves orientations. Upon these assumptions, we can define in Ω the local orthonormal basis $\{\underline{e}_k^{\phi}\}_{k=1}^d$ satisfying

ETCs aim at linking together the mechanical fields, i.e. normal stresses and traces, at the mid-surface of the intermediate layer. In the following we denote by Γ this mid-surface, and we define

the geometrical transformations from the mid-surface to the upper and lower surfaces. Note that, from the regularity assumptions on $\underline{\Phi}$, these transformations are diffeomorphisms, and in the particular case where $\underline{\Phi}$ is the identity transformation, they boil down to simple translations of $\pm \frac{1}{2} \ell^{\circ,\eta}$ in the stratification direction.

Material properties of the plies and intermediate layers. In the following, the mechanical properties of the plies and the intermediate layers identified at ω_{\star} are denoted by

$$\left\{ \left(\mathcal{C}^{\circ}_{\star,i}, \mathcal{D}^{\circ}_{\star,i}, \rho_{\star,i} \right) \right\}_{i=1}^{2} \quad \text{and} \quad \left(\mathcal{C}^{\circ,\eta}_{\star}, \mathcal{D}^{\circ,\eta}_{\star}, \rho^{\eta}_{\star} \right),$$

where $\rho_{\star,i}$ (or ρ_{\star}^{η}) are the mass densities, the real part $\mathbb{C}^{\circ}_{\star,i}$ (or $\mathbb{C}^{\circ,\eta}_{\star}$) and imaginary part $\mathbb{D}^{\circ}_{\star,i}$ (or $\mathbb{D}^{\circ,\eta}_{\star}$) of the stiffness tensors are symmetric and positive definite fourth order tensors, satisfying the low-loss assumption (1) and defined on the prior geometry Ω° . We consider general anisotropic stiffness tensors for the plies, and we denote by $\mathbb{C}_{\star,i}$ and $\mathbb{D}_{\star,i}$ the resulting tensors in (47). Concerning the intermediate layers we make the assumption of isotropic materials. Their corresponding mechanical properties in the curved configuration are simply defined by the Lamé coefficients $\lambda_{\star}^{C,\eta}, \mu_{\star}^{C,\eta}$ for the real part, and $\lambda_{\star}^{D,\eta}, \mu_{\star}^{D,\eta}$ for the imaginary part.

3.2. Definition of standard spring-mass ETCs

For every sub-domains Ω_i , we denote by $\underline{\sigma}_i$ the corresponding stress tensor field, and we associate to each interphase the following mechanical fluxes

where <u>n</u> is the normal vector field of the mid-surface Γ oriented from Γ^- to Γ^+ . The mean value and jump of the mechanical fluxes at the mid-surface are denoted by

As in [48, 49], we replace the propagator in the intermediate layer by spring-mass transmission conditions. To this purpose, we introduce $\{C_{\star}^{\eta,k}\}_{k=1}^{d}$, $\{D_{\star}^{\eta,k}\}_{k=1}^{d}$ and $\{M_{\star}^{\eta,k}\}_{k=1}^{d}$ the effective stiffness, viscosity and inertial coefficients of the interphase. Denoting by $\{\underline{b}_k\}_{k=1}^{d}$ an orthonormal basis associated to the mid-surface, we define the following symmetric and positive second order tensors

The transmission conditions between plies read, in frequency domain,

where $\hat{\cdot}$ is the time domain Fourrier transform. A significant amount of work has been dedicated to the construction of relevant effective coefficients. As an example, in the context of laminated composites, authors is [50, 51] use the following definition, based upon the assumption of an isotropic material,

For the inertial terms authors in [49, 52] consider the following definition

Proposing an expression of these coefficients, typically using an asymptotic expansion w.r.t. the ratio of the thickness over the wavelength, is still an active field of research. For instance, spring-mass models can be used to represent complex configurations such as damaged interfaces [53] or distributions of interfacial flaws [54, 55]. It should be noted however that the ETCs given in (49) are an approximation of the rigorous asymptotic model, derived in [56]. More precisely, they correspond to neglecting terms related to the surface gradient of the mean and jump of the trace, which we can expect to be a reasonable approximation in the case of small contrasts.

3.3. ETCs through mortar elements

The mortar element method [27, 28, 57, 58] is a domain decomposition approach aiming at coupling independent space discretizations. It has been successfully applied to elastodynamics and wave propagation problems [59, 60, 61, 62, 63]. More recently [20], this method has been used to couple different formulations, e.g. elastodynamics, acoustics and corresponding Perfectly Matched Layers (PMLs) [64, 65, 66] formulations. In the present work, we extend this approach to visco-elastic formulations coupled with spring-mass ETCs. To start with, let us introduce the following Lagrange multipliers

Proof. First, from the second relation in (49) and the definition of the multiplier $\underline{\mu}$ we deduce the straightforward expression of $\underline{\underline{M}}^{\eta}$. Second, from the definition of the multiplier $\underline{\lambda}$, the first equation in (53) reads in frequency domain

where \underline{I} is the identity second order tensor. Interestingly enough, we remark that this system is identical, modulo the dimension of the tensors, to the system (24) obtained for the calibration of the Maxwell model, yielding the expressions (54) of \underline{S}^{η} and \underline{H}^{η} .

Within each sub-domain Ω_1 and Ω_2 we consider Zener field equations (37) satisfied by the displacements \underline{u}_1 and \underline{u}_2 , and the internal variables $\underline{\underline{s}}_1$ and $\underline{\underline{s}}_2$ related to the stress tensor fields $\underline{\underline{\sigma}}_1$ and $\underline{\underline{\sigma}}_2$ through (36). Prior to propose the weak formulation of the mortar coupling scheme, we start with the following lemma expressing the boundary terms appearing in the Green identity.

$$\begin{cases} \frac{1}{2}\mathbb{C}_{1}\frac{\overrightarrow{U}_{1}^{n+1}-2\overrightarrow{U}_{1}^{n}+\overrightarrow{U}_{1}^{n-1}}{\Delta t^{2}} + \frac{1}{2}\mathbb{C}_{2}\frac{\overrightarrow{U}_{2}^{n+1}-2\overrightarrow{U}_{2}^{n}+\overrightarrow{U}_{2}^{n-1}}{\Delta t^{2}} - \mathbb{G}^{\eta}\frac{\overrightarrow{M}^{n+\frac{1}{2}}+\overrightarrow{M}^{n-\frac{1}{2}}}{2} = 0, \\ \mathbb{C}_{1}\frac{\overrightarrow{U}_{1}^{n+1}-\overrightarrow{U}_{1}^{n-1}}{2\Delta t} - \mathbb{C}_{2}\frac{\overrightarrow{U}_{2}^{n+1}-\overrightarrow{U}_{2}^{n-1}}{2\Delta t} + \mathbb{S}^{\eta}\frac{\overrightarrow{\Lambda}^{n+\frac{1}{2}}-\overrightarrow{\Lambda}^{n-\frac{1}{2}}}{\Delta t} + \mathbb{H}^{\eta}\frac{\overrightarrow{\Lambda}^{n+\frac{1}{2}}+\overrightarrow{\Lambda}^{n-\frac{1}{2}}}{2} = 0. \end{cases}$$

Although we do not provide rigorous consistency analysis, we can expect the scheme (62) - (63) to be of order two, since every fully discrete equations are centered. Remark that in (62) clearly appear the following quantities

which, from (57), can be interpreted as the fully discrete representation of the fluxes.

3.4. Stability condition of the fully discrete propagator of the coupled system

Following the procedure used in the previous section, we start by giving a energy identity for the fully discrete scheme (62) - (63).

Lemma 9. For a sub-domain index $i \in \{1, 2\}$, we consider the energy functionals $\mathbf{E}_{\text{zn},i}^{n+\frac{1}{2}}$ defined in (41), and the dissipative functionals $\mathbf{D}_{\mathcal{E}_{\tau,i}}^{n}$ defined in (40). Furthermore, denoting by

and $\|\cdot\|_{M^{\eta}}$, $\|\cdot\|_{S^{\eta}}$ and $\|\cdot\|_{H^{\eta}}$ the discrete norms associated to the matrices \mathbb{M}^{η} , \mathbb{S}^{η} and \mathbb{H}^{η} respectively, we define the functionals

$$\begin{aligned} \left\| \mathbf{K}_{M^{\eta}}^{n+\frac{1}{2}} &= \frac{1}{2} \left\| \frac{1}{2} \mathbb{C}_{1} \frac{\overrightarrow{U}_{1}^{n+1} - \overrightarrow{U}_{1}^{n}}{\Delta t} + \frac{1}{2} \mathbb{C}_{2} \frac{\overrightarrow{U}_{2}^{n+1} - \overrightarrow{U}_{2}^{n}}{\Delta t} \right\|_{M^{\eta}}^{2}, \\ \mathbf{P}_{S^{\eta}}^{n+\frac{1}{2}} &= \frac{1}{2} \left\| \overrightarrow{\Lambda}^{n+\frac{1}{2}} \right\|_{S^{\eta}}^{2}, \\ \mathbf{D}_{H^{\eta}}^{n} &= \left\| \frac{\overrightarrow{\Lambda}^{n+\frac{1}{2}} + \overrightarrow{\Lambda}^{n-\frac{1}{2}}}{2} \right\|_{H^{\eta}}^{2}, \\ 23 \end{aligned}$$
(64)

and we consider the following energy functional

$$\mathbf{E}_{\eta}^{n+\frac{1}{2}} = \mathbf{K}_{M^{\eta}}^{n+\frac{1}{2}} + \mathbf{P}_{S^{\eta}}^{n+\frac{1}{2}}.$$
 (65)

The solution of (62) – (63) satisfies the following energy identity

$$\sum_{i \in \{1,2\}} \frac{\mathbf{E}_{\mathrm{zn},i}^{n+\frac{1}{2}} - \mathbf{E}_{\mathrm{zn},i}^{n-\frac{1}{2}}}{\Delta t} + \frac{\mathbf{E}_{\eta}^{n+\frac{1}{2}} - \mathbf{E}_{\eta}^{n-\frac{1}{2}}}{\Delta t} = -\sum_{i \in \{1,2\}} \mathbf{D}_{\mathcal{E}_{\tau,i}}^{n} - \mathbf{D}_{H^{\eta}}^{n} \le 0.$$

Proof. To start with, we follow the demonstration leading to the identity energy (42) for each sub-domains. Thus, multiplying the first and second relation in (62) by $\frac{1}{2\Delta t}(\vec{U}_1^{n+1} - \vec{U}_1^{n-1})^{\mathsf{T}}$ and $\frac{1}{2\Delta t}(\vec{U}_2^{n+1} - \vec{U}_2^{n-1})^{\mathsf{T}}$ respectively, and multiplying the second relation in (63) by $\frac{1}{\Delta t}(\vec{\Lambda}^{n+\frac{1}{2}} - \vec{\Lambda}^{n-\frac{1}{2}})^{\mathsf{T}}$, we obtain

$$-\sum_{i\in\{1,2\}} \mathbf{D}_{\mathcal{E}_{\tau,i}^{n}}^{n} - \mathbf{D}_{H^{\eta}}^{n} = \sum_{i\in\{1,2\}} \frac{\mathbf{E}_{\mathrm{zn},i}^{n+\frac{1}{2}} - \mathbf{E}_{\mathrm{zn},i}^{n-\frac{1}{2}}}{\Delta t} + \left(\frac{\overrightarrow{\Lambda}^{n+\frac{1}{2}} + \overrightarrow{\Lambda}^{n-\frac{1}{2}}}{2}\right)^{\mathsf{T}} \mathbb{S}^{\eta} \left(\frac{\overrightarrow{\Lambda}^{n+\frac{1}{2}} - \overrightarrow{\Lambda}^{n-\frac{1}{2}}}{\Delta t}\right) + \frac{1}{2} \left(\frac{\overrightarrow{U}_{1}^{n+1} - \overrightarrow{U}_{1}^{n-1}}{2\Delta t}\right)^{\mathsf{T}} \mathbb{C}_{1}^{\mathsf{T}} \left(\frac{\overrightarrow{M}^{n+\frac{1}{2}} + \overrightarrow{M}^{n-\frac{1}{2}}}{2}\right) + \frac{1}{2} \left(\frac{\overrightarrow{U}_{2}^{n+1} - \overrightarrow{U}_{2}^{n-1}}{2\Delta t}\right)^{\mathsf{T}} \mathbb{C}_{2}^{\mathsf{T}} \left(\frac{\overrightarrow{M}^{n+\frac{1}{2}} + \overrightarrow{M}^{n-\frac{1}{2}}}{2}\right).$$
(67)

First, let us remark that

$$\frac{\overrightarrow{\Lambda}^{n+\frac{1}{2}} + \overrightarrow{\Lambda}^{n-\frac{1}{2}}}{2} \Big)^{\mathsf{T}} \mathbb{S}^{\eta} \Big(\frac{\overrightarrow{\Lambda}^{n+\frac{1}{2}} - \overrightarrow{\Lambda}^{n-\frac{1}{2}}}{\Delta t} \Big) = \frac{\mathbf{P}_{S^{\eta}}^{n+\frac{1}{2}} - \mathbf{P}_{S^{\eta}}^{n-\frac{1}{2}}}{\Delta t}$$

Second, using the first relation in (63), we can give the following expression for the last terms in (67)

which is equivalent to

$$\frac{1}{4\Delta t} \left\{ \sum_{i \in \{1,2\}} \frac{1}{2} \left\| \mathbb{C}_{i} \frac{\overrightarrow{U}_{i}^{n+1} - \overrightarrow{U}_{i}^{n}}{\Delta t} \right\|_{M^{\eta}}^{2} - \frac{1}{2} \left\| \mathbb{C}_{i} \frac{\overrightarrow{U}_{i}^{n} - \overrightarrow{U}_{i}^{n-1}}{\Delta t} \right\|_{M^{\eta}}^{2} + \left(\frac{\overrightarrow{U}_{1}^{n+1} - \overrightarrow{U}_{1}^{n}}{\Delta t} \right)^{\mathsf{T}} \mathbb{C}_{1}^{\mathsf{T}} \mathbb{M}^{\eta} \mathbb{C}_{2} \left(\frac{\overrightarrow{U}_{2}^{n+1} - \overrightarrow{U}_{2}^{n}}{\Delta t} \right) - \left(\frac{\overrightarrow{U}_{1}^{n} - \overrightarrow{U}_{1}^{n-1}}{\Delta t} \right)^{\mathsf{T}} \mathbb{C}_{1}^{\mathsf{T}} \mathbb{M}^{\eta} \mathbb{C}_{2} \left(\frac{\overrightarrow{U}_{2}^{n+1} - \overrightarrow{U}_{2}^{n}}{\Delta t} \right) - \left(\frac{\overrightarrow{U}_{1}^{n} - \overrightarrow{U}_{1}^{n-1}}{\Delta t} \right)^{\mathsf{T}} \mathbb{C}_{1}^{\mathsf{T}} \mathbb{M}^{\eta} \mathbb{C}_{2} \left(\frac{\overrightarrow{U}_{2}^{n} - \overrightarrow{U}_{2}^{n-1}}{\Delta t} \right) \right\},$$

leading to (66) using the square of binomials.

Note that the energy functional (65) representing the kinetic and potential energy associated to the interphase is unconditionally positive w.r.t. the time step. Hence, deriving a stability condition for the discrete coupling scheme can be simply done by insuring that energy functionals associated to each subdomains are positive, which is exactly the result provided in Theorem 5. More precisely we can give the following stability result.

Theorem 6. For a sub-domain index $i \in \{1, 2\}$, we denote by $\mathbb{K}_{\mathbb{D}_{2}^{m}}$ the matrices associated to the discrete Zener propagators in Ω_i , defined as in (44). The coupling scheme (62) – (63) is stable upon the following condition

$$\Delta t \le \min\left(\frac{2}{\sqrt{r(\mathbb{M}_{\rho_1}^{-1}\mathbb{K}_{\mathcal{D}_1^{n}})}}, \frac{2}{\sqrt{r(\mathbb{M}_{\rho_2}^{-1}\mathbb{K}_{\mathcal{D}_2^{n}})}}\right).$$

In other words, the introduction of the ETCs using the mortar element method does not influence the stability condition of each sub-domains, for any values of the effective mechanical parameters of the interphase.

3.5. Resolution algorithm using the Schur complement method

In order to give practical solving steps for the numerical scheme (62) - (63), we start by separating the computation of the internal variables from the displacement unknowns. This is possible since the internal variables appear in the displacement equations in an explicit manner. The coupled system satisfied by the displacement unknowns and the Lagrange multipliers can be expressed as

$$\begin{pmatrix} \mathbb{M}_{\rho_1} & \frac{\Delta t^2}{4} \mathbb{C}_1^{\mathsf{T}} & -\frac{\Delta t^2}{2} \mathbb{C}_1^{\mathsf{T}} \\ \mathbb{M}_{\rho_2} & \frac{\Delta t^2}{4} \mathbb{C}_2^{\mathsf{T}} & \frac{\Delta t^2}{2} \mathbb{C}_2^{\mathsf{T}} \\ -\frac{1}{2} \mathbb{C}_1 & -\frac{1}{2} \mathbb{C}_2 & \frac{\Delta t^2}{2} \mathbb{G}^{\eta} \\ \mathbb{C}_1 & -\mathbb{C}_2 & (2\mathbb{S}^{\eta} + \Delta t\mathbb{H}^{\eta}) \end{pmatrix} \begin{pmatrix} \overline{U}_1^{n+1} \\ \overline{U}_2^{n+1} \\ \overline{M}^{n+\frac{1}{2}} \\ \overline{\Lambda}^{n+\frac{1}{2}} \end{pmatrix} = \begin{pmatrix} \overline{F}_1 \\ \overline{F}_2 \\ \overline{F}_{\mu} \\ \overline{F}_{\lambda} \end{pmatrix},$$
(69)

where the various right-hand sides of this system are defined as

$$\begin{split} \left| \overrightarrow{F}_{1} &= -\mathbb{B}_{1}^{\mathsf{T}} \overrightarrow{S}_{1}^{n} - \Delta t^{2} \mathbb{K}_{\mathbb{C}_{1}^{nn}} \overrightarrow{U}_{1}^{n} + \mathbb{M}_{\rho_{1}} \left(2\overrightarrow{U}_{1}^{n} - \overrightarrow{U}_{1}^{n-1} \right) + \frac{\Delta t^{2}}{2} \mathbb{C}_{1}^{\mathsf{T}} \overrightarrow{\Lambda}^{n-\frac{1}{2}} - \frac{\Delta t^{2}}{4} \mathbb{C}_{1}^{\mathsf{T}} \overrightarrow{M}^{n-\frac{1}{2}}, \\ \left| \overrightarrow{F}_{2} &= -\mathbb{B}_{2}^{\mathsf{T}} \overrightarrow{S}_{2}^{n} - \Delta t^{2} \mathbb{K}_{\mathbb{C}_{2}^{nn}} \overrightarrow{U}_{2}^{n} + \mathbb{M}_{\rho_{2}} \left(2\overrightarrow{U}_{2}^{n} - \overrightarrow{U}_{2}^{n-1} \right) - \frac{\Delta t^{2}}{2} \mathbb{C}_{2}^{\mathsf{T}} \overrightarrow{\Lambda}^{n-\frac{1}{2}} - \frac{\Delta t^{2}}{4} \mathbb{C}_{2}^{\mathsf{T}} \overrightarrow{M}^{n-\frac{1}{2}}, \\ \left| \overrightarrow{F}_{\mu} &= -\frac{1}{2} \mathbb{C}_{1} \left(2\overrightarrow{U}_{1}^{n} - \overrightarrow{U}_{1}^{n-1} \right) - \frac{1}{2} \mathbb{C}_{2} \left(2\overrightarrow{U}_{2}^{n} - \overrightarrow{U}_{2}^{n-1} \right) - \frac{\Delta t^{2}}{2} \mathbb{G}^{\eta} \overrightarrow{M}^{n-\frac{1}{2}}, \\ \left| \overrightarrow{F}_{\lambda} &= \mathbb{C}_{1}^{\mathsf{T}} \overrightarrow{U}_{1}^{n-1} - \mathbb{C}_{2}^{\mathsf{T}} \overrightarrow{U}_{2}^{n-1} + \left(2\mathbb{S}^{\eta} - \Delta t\mathbb{H}^{\eta} \right) \overrightarrow{\Lambda}^{n-\frac{1}{2}}. \end{split}$$

We define the following matrices

$$\mathbb{A} = \begin{pmatrix} \mathbb{M}_{\rho_1} \\ \mathbb{M}_{\rho_2} \end{pmatrix}, \quad \mathbb{B} = \begin{pmatrix} \frac{\Delta t^2}{4} \mathbb{C}_1 & \frac{\Delta t^2}{4} \mathbb{C}_2 \\ -\frac{\Delta t^2}{2} \mathbb{C}_1 & \frac{\Delta t^2}{2} \mathbb{C}_2 \end{pmatrix}, \quad \mathbb{C} = \begin{pmatrix} -\frac{1}{2} \mathbb{C}_1 & -\frac{1}{2} \mathbb{C}_2 \\ \mathbb{C}_1 & -\mathbb{C}_2 \end{pmatrix}, \quad \mathbb{D} = \begin{pmatrix} \frac{\Delta t^2}{2} \mathbb{G}^{\eta} \\ (2\mathbb{S}^{\eta} + \Delta t \mathbb{H}^{\eta}) \end{pmatrix},$$

representing the block matrices of the system (69). With these notations, the Schur complement matrix is defined by

Introducing two intermediate variables $\overrightarrow{U}_1^{\star}$ and $\overrightarrow{U}_2^{\star}$, we can obtain, from applying a Schur complement method, the following solving steps:

Note that, using mass-lumping technique the matrix \mathbb{A} is diagonal thus trivially invertible. However, for this strategy to be relevant, we need to verify that the Schur matrix \mathbb{S} is invertible.

Lemma 10. The Schur matrix defined in (70) is symmetric and positive definite.

Proof. Remarking that $\mathbb{B} = -\frac{\Delta t^2}{2}\mathbb{C}$, we have

where \cdot represents the block matrix deduced by symmetry. Let $\overrightarrow{\Lambda}$ and \overrightarrow{M} be two non-zero vectors of \mathbb{R}^{M_h} and define

we can verify that

$$\overrightarrow{X}^{\mathsf{T}}\mathbb{S}\overrightarrow{X} = \frac{\Delta t^2}{2} \left(\overrightarrow{M}^{\mathsf{T}}\mathbb{G}^{\eta}\overrightarrow{M} + \overrightarrow{T_{-}}^{\mathsf{T}}\mathbb{C}_{1}\mathbb{M}_{\rho,1}^{-1}\mathbb{C}_{1}^{\mathsf{T}}\overrightarrow{T_{-}} + \overrightarrow{T_{+}}^{\mathsf{T}}\mathbb{C}_{2}\mathbb{M}_{\rho,2}^{-1}\mathbb{C}_{2}^{\mathsf{T}}\overrightarrow{T_{+}} \right) + \overrightarrow{\Lambda}^{\mathsf{T}} \left(2\mathbb{S}^{\eta} + \Delta t\mathbb{H}^{\eta} \right) \overrightarrow{\Lambda} > 0.$$

3.6. Lumped Schur complement matrix in the conform case

In practice, we define the discrete space X_h as one of the volume trace space, i.e.

This approximation is similar to (55), and corresponds to neglecting the effect of the deformation ϕ^- on the surface mesh. Introducing the following bilinear form

and its corresponding finite element representation $\mathbb{M}_{\Gamma} \in \mathcal{M}_{M_h,M_h}(\mathbb{R})$, the definition (72) of X_h entails some simplifications of the expressions of the bilinear forms (60). In particular, denoting by $\mathbb{T}_1 \in \mathcal{M}_{M_h,N_{1,h}}(\mathbb{R})$ the matrix selecting the values on Γ^- of a finite element vector in $V_{h,1}$, we have

Furthermore, upon the assumption of conform interfaces, i.e.



$$\mathbb{C}_2 = \mathbb{M}_{\Gamma} \mathbb{T}_2.$$

With this specific decomposition of the coupling bilinear forms, and assuming that a mass lumping technique is used when assembling \mathbb{M}_{Γ} , we can verify, from the expression (71), that the Schur matrix is a block diagonal matrix, each block being of size $2d \times 2d$. Therefore it can be efficiently inverted, each block problems in parallel. In other words, in the conform case, the computational overhead of the introduction of imperfect transmission conditions using the mortar element method is very limited.

3.7. Numerical illustrations on a two-dimensional configuration

We consider a 2D "plane" case, i.e. $\underline{\Phi}$ reduces to the identity transformation. The dimensions of the domain are set to $L_1 = 20$ mm and $L_2 = 10$ mm. We consider two inviscid and identical materials in Ω_1 and Ω_2 , i.e.

$$\mathcal{C}_{\star,1} = \mathcal{C}_{\star,2} = \mathcal{C}_{\star}, \quad \rho_{\star,1} = \rho_{\star,2} = \rho_{\star},$$

and we set to zero the imaginary parts $\mathcal{D}_{\star,1}$, and $\mathcal{D}_{\star,2}$. Furthermore, we assume that the target mechanical properties are isotropic, and correspond to a steel material. It is characterized by the following mass density $\rho_{\star} = 8 \text{ g} \cdot \text{cm}^{-3}$, and Lamé coefficients $\lambda_{\star} = 104$ GPa and $\mu_{\star} = 78$ GPa. Concerning the intermediate layers, we define the following mechanical parameters

$$\rho_{\star}^{\eta} = \rho_{\star}, \quad \lambda_{\star}^{C,\eta} = \alpha^2 \lambda_{\star} + 2(1 - \alpha^2)\mu_{\star}, \quad \mu_{\star}^{C,\eta} = \alpha^2 \mu_{\star}, \quad \text{and} \quad \lambda_{\star}^{D,\eta} = \mu_{\star}^{C,\eta} = 0, \tag{73}$$


where $\alpha \leq 1$ is a contrast coefficient. Denoting by $v_{\star,L}$ and $v_{\star,T}$ the velocity of longitudinal and transverse waves in the material, and by $v_{\star,L}^{\eta}$ and $v_{\star,T}^{\eta}$ the corresponding velocities in the interphase, the previous expression (73) of the Lamé coefficients were derived so that

$$v_{\star,L}^{\eta} = \alpha v_{\star,L}, \text{ and } v_{\star,T}^{\eta} = \alpha v_{\star,T}.$$

On the upper surface of the domain, we impose a normal surface load with a centered support of 2 mm with the following time dependency

$$f(t) = \cos(2\pi f(t - t_0)) \exp\left(-\frac{(t - t_0)^2}{\sigma_f^2}\right),$$
(74)

with F = 6 MHz, $t_0 = 0.65 \ \mu s$ and $\sigma_f = 0.2 \ \mu s^{-1}$. In each sub-domain, we set the identical mesh steps of $h_x = h_y = 0.125$ mm and use finite elements of order 4. For clarity purposes, we illustrate this simple configuration in Figure 3a.




Figure 5: Comparing the displacement field obtained when meshing the intermediate layer with the solution obtained from effective transmission conditions. Solution obtained with $\alpha = \frac{1}{5}$ and $\ell^{\eta} = 100 \ \mu m$ at the observation line at $x = 8 \ \text{mm}$.

To start with, we consider the case of a relatively high contrast of $\alpha = \frac{1}{5}$ and an interphase thickness of $\ell^{\eta} = 10 \ \mu m$. We show in Figure 3b a snapshot of the solution obtained at the arrival time of the first longitudinal wave packet. In this snapshot, the intermediate layer is meshed with one element of order 2 in the thickness direction. At the abscissa x = 8 mm we consider an observation line. In Figure 4a and 4b we compare the first and second components of the displacement field obtained either by meshing the




Figure 6: Evolution of the relative error $e(\alpha, \ell^{\eta})$ between the numerical solution with a meshed intermediate layer and the numerical solution obtained using ETCs, for different contrast coefficients and thicknesses.

intermediate layer or by applying effective transmission conditions. We observe a very good agreement between the two solutions.

In a second numerical experiment, we impose the same contrast coefficient but we increase the thickness of the intermediate layers to $\ell^{\eta} = 100 \ \mu m$. We show in Figure 3c the snapshot of the solution obtained with a meshed intermediate layer using finite elements of order 3 in the thickness direction. Compare to the previous case we observe a significant longitudinal reflection and some contributions trapped within the interphase. We also extract the displacement fields at an observation line at x = 8 mm and compare the numerical solution obtained from meshed layers and effective transmission conditions. While we keep a reasonable agreement for the second component, the first component, gathering most of the transverse contributions of higher frequency, are not adequately captured using ETCs. In particular, the solution obtained from ETCs does not manage to represent the spatial variation around the thin layer location, around y = 5 mm.

To better illustrate the evolution of the error introduced by the effective transmision conditions, we propose to consider the following quantity depending on the contrast coefficient and the thickness of the intermediate layer

$$e(\alpha, \ell^{\eta}) = \max_{n} \frac{\|u_{h}^{n} - u_{h}^{\eta, n}\|_{L^{2}(\Omega_{1} \cup \Omega_{2})}}{\|u_{h}^{n}\|_{L^{2}(\Omega_{1} \cup \Omega_{2})}},$$

where u_h^n is the numerical solution obtained with meshed interphase and $u_h^{\eta,n}$ is the one obtained using ETCs. In Figure 6 we plot this relative error for $\ell^{\eta} \in [10^{-3}; 10^{-1}]$ and $\alpha \in \{\frac{1}{5}, \frac{1}{3}, 1\}$. We clearly observe that, for a fixed thickness, as the contrast coefficient decreases, the relative error increases. Interestingly enough, for every tested values of the contract coefficient, we observe a linear asymptotic behavior w.r.t. ℓ^{η} . Note that authors in [56] derive an asymptotic model of $O((\ell^{\eta})^3)$. Nonetheless it requires surface gradient terms which are more involved computationally and, in particular, it would necessarily leads to sparse Schur matrices, even with conform interfaces.

4. Numerical illustration: application to UT of a laminated composite

In this section we illustrate our modeling strategy by considering a more realistic 3D configuration. In this configuration, we assume that the specimen under study is composed of 20 anisotropic visco-elastic plies

and 19 intermediate layers. The geometry of the domain, prior to its deformation, is characterized by the following lengths

$$L_1 = L_2 = 10 \text{ mm}, \quad L_3 = 4.995 \text{ mm}, \quad \ell^{\circ,\eta} = 5 \cdot 10^{-3} \text{ mm}$$

so that the plies have a thickness of $245 \cdot 10^{-3}$ mm in the "plane" geometry. The mass density of the plies is set to $\rho_{\star,i} = 1.6 \text{ g} \cdot \text{cm}^{-3}$. For the sub-domain with odd or even indexes, the real part of the target constitutive law reads, using the Voigt notation,

$$\mathcal{C}^{\circ}_{\star,\text{odd}} = \begin{pmatrix} 139 & 6 & 6 & & & \\ 6 & 12.1 & 5.5 & & & \\ 6 & 5.5 & 12.1 & & & \\ & & & 3.3 & & \\ & & & & 6.6 & \\ & & & & & 6.6 \end{pmatrix} \text{ GPa, } \mathcal{C}^{\circ}_{\star,\text{even}} = \begin{pmatrix} 12.1 & 6 & 5.5 & & & \\ 6 & 139 & 6 & & & \\ 5.5 & 6 & 12.1 & & & \\ & & & & 6.6 & & \\ & & & & & 6.6 \end{pmatrix} \text{ GPa, }$$

which corresponds to transverse isotropic constitutive law. For odd indexes, it represents plies with a fiber orientation equals to \underline{e}_1 direction, while, for even indexes, the fiber orientation is \underline{e}_2 . Using the viscosity coefficients proposed in [67], we set the imaginary part of the target constitutive law to

$$\mathcal{D}^{\circ}_{\star,\text{odd}} = \begin{pmatrix} 11.3 & 0.4 & 0.4 & & & \\ 0.4 & 0.7 & 0.4 & & & \\ 0.4 & 0.4 & 0.7 & & & \\ & & & 0.15 & & \\ & & & & 0.2 & & \\ & & & & & 0.2 \end{pmatrix} \text{ GPa, } \mathcal{D}^{\circ}_{\star,\text{even}} = \begin{pmatrix} 0.7 & 0.4 & 0.4 & & & \\ 0.4 & 11.3 & 0.4 & & & \\ 0.4 & 0.4 & 0.7 & & & \\ & & & & 0.2 & & \\ & & & & 0.15 & & \\ & & & & & 0.2 \end{pmatrix} \text{ GPa,}$$

and we assume that these mechanical properties have been characterized at a frequency of interest of $f_{\star} = 5$ MHz, with $\omega_{\star} = 2\pi f_{\star}$. The intermediate layers are epoxy layers, assumed to be inviscid materials with the following mass density and Lamé coefficients

$$\rho_{\star}^{\eta} = 1.23 \text{ g} \cdot \text{cm}^{-3}, \quad \lambda_{\star}^{\eta} = 4.4 \text{ GPa}, \quad \mu_{\star}^{\eta} = 1.6 \text{ GPa}.$$

The global transformation $\underline{\Phi}$ of the geometry is a simple cylindrical transformation of radius 10 mm and angle $\frac{\pi}{4}$ rad. This transformation is affecting the definition of the mechanical properties of the plies in virtue of (47). On the upper surface of the domain, we impose a normal surface load with a centered circular support of radius 2 mm. The time dependency of this surface load is as in (74), with F = 5 MHz, $t_0 = 0.65 \ \mu s$ and $\sigma_f = 0.25 \ \mu s^{-1}$. We consider a maximal time of $2 \ \mu s$, which roughly corresponds to the time required for the principal wave packet to reach the lower surface of the domain. Concerning the space discretization of the domain, in the (x, y)-plane we set the mesh step to $285 \cdot 10^{-3}$ mm and we use finite elements of order 4. Within each ply's thickness we use two elements of order 4, and in the case of meshed intermediate layers we use one element of order 2.





Figure 7: Comparing snapshots of the magnitude of the displacement field for the inviscid model (top row) and Zener model (bottom row).


Figure 8: Comparing the third component of the displacement field at the centered observation line at x = y = 5 mm at time $t = 2 \ \mu s.$

As a first step, we neglect the viscous part of the target constitutive law and we compare the inviscid model with either meshed intermediate layers or ETCs. We show in Figure 7 a snapshot of the numerical solution obtained in the former case, and in Figure 8a we plot the third component of both solutions over the line x = y = 5 mm. We observe a very good agreement between the two numerical solutions. In Table (2) we compare various characteristics of the simulations, carried out on a laptop PC Intel^(R) CoreTM i7 - 8850H at 2.6 GHz. We observe that we have close to a factor three between the timesteps, leading to a factor three in terms of computational time. In terms of memory load we observe however a factor two when using ETCs, which is due to the storage of the inverse of the Schur matrices at each interface between plis.

In a second step, we compute the solution obtained with a Kelvin-Voigt, a Maxwell and a Zener model. In the three cases we use ETCs to model the intermediate layers between plies. In Tables 3, 4 and 5 we gather the various computation costs associated to each visco-elastic propagator. We observe, on this practical case, the hierarchy described in Section 2.8: the Maxwell propagator is as efficient as the inviscid case; the Zener model exhibits a doubled response time, mainly due to the second application of a stiffness operator; the Kelvin-Voigt is roughly four times more expensive than the Maxwell propagator due to two stiffness operations, and a smaller timestep.



We show in Figure 7 the snapshots obtained from the Zener model at specific times, to be compared with the inviscid case. In Figure 8b, we plot the third component of both solutions over the observation line x = y = 5 mm at time $t = 2 \mu s$, clearly showing the effect of the attenuation.

Additionally, we consider an observation point of coordinates (x, y, z) = (5, 5, 0) situated at the bottom of the observation line. After increasing the maximal time to $4 \mu s$, we plot over time in Figure 9a the solutions of the inviscid and the three visco-elatic models. For visibility purposes, we plot in Figure 9b only the signals obtained from the viscous propagators. These plots demonstrate the validity of our calibration procedure since the visco-elastic solutions give similar results.

To better understand their differences, we analyze the frequency content of the main wave packet. To do so, we select the numerical signals up to time $t = 3 \ \mu s$ and apply a simple zero padding. On these windowed signals, we apply a time-domain Fourier transform. The results of these operations are presented in Figure 10a. We clearly see the global effect of the attenuation, which is equivalently recovered by the three visco-elastic models. At the frequency of interest -5 MHz for this specific case - the corresponding three curves match. Away from the frequency of interest, we observe some frequency shifts. As detailed in Section 2.8, these shifts are due to the frequency dependency of the attenuation law associated to each model, namely: constant, (locally) linear and quadratic functions for the Maxwell, Zener and the Kelvinvoigt case respectively - see Figure 2a. From the frequency content of the signals, we are able to compute the attenuation laws associated to each model. We present them in Figure 10b. The three curves match at


(a) Meshed intermediate layers vs. ETCs (inviscid case).

5. Conclusion and perspectives

In this work we have proposed a systematic approach to compare explicit fully discrete wave propagators of standard visco-elastic models. By proposing a common and simple calibration procedure for these models, applicable in the general context of anisotropic constitutive laws, we were able to provide qualitative analysis of the corresponding numerical schemes. In particular, we have studied how the stability conditions may evolve w.r.t the quality factor or the spatial discretization. This general analysis has been illustrated with various numerical solutions in 1D and 3D contexts.

In the second part of this communication, we have shown how one can integrate effective transmission conditions to represent isotropic intermediate layers between curved anisotropic visco-elastic domains using the mortar element method. Based upon the stability analysis of the visco-elastic models carried out in the first part, we have proven that the introduction of the mortar elements does not modify the stability condition of the coupled scheme, this for any effective parameters of the transmission conditions. Additionally, even though this approach is valid for non-conform space discretization, in the specific case of conform interfaces we have obtained an explicit algorithm. We have proposed 2D illustrations providing numerical evidence of the validity of this strategy, and a numerical study on the convergence of the solution with respect to thickness of the intermediate layer. In a 3D context, we have considered the case of wave propagation within a curved visco-elastic laminated material. In this case, the use of effective transmission conditions to represent the epoxy intermediate layers has yielded a significant improvement, in terms of computational costs, compared to the standard numerical solution obtained by meshing these layers.

Several perspectives related to the presented work may be envisioned. Concerning the comparison of the discrete propagators, we may consider the generalized Zener model, which in essence is an extension of the model (34) with multiple relaxation mechanisms. In this context, the main difficulty would be to propose an explicit calibration of this model applicable for the anisotropic case. In relation to this issue, we may refer to the recent advances of [68, 69]. Concerning the incorporation of effective transmissions conditions, it seems possible, albeit more involved, to incorporate more elaborate asymptotic models such as the one proposed in [56]. Using this type of transmission conditions, yielding better convergence w.r.t. the intermediate layer thickness, may be interesting in order to address a larger range of UT configurations. A rather more direct perspective is to consider the coupling between a fluid domain (acoustic formulation) and a solid domain (elastodynamic formulation) with standard ETCs. A typical example of application is the simulation of UT of immersed and coated materials. Note that, in this perspective, being able to use nonconforming space discretization thanks to the mortar element method is a major asset. Another natural perspective is the use of these ETCs to model delamination flaws, typically appearing after impacts on laminated composite structures. The major goal of this approach would be to incorporate flaws of arbitrary shapes without penalizing the computational cost of the numerical solver. As a more general perspective, it seems promising to rely on the fact that the coupling scheme does not depend on the effective parameters of the interphase. This robustness may be put to good use within an inverse or imaging process. For example, using specific ETCs to represent delamination flaws, we may rely on variational data-assimilation approaches [70, 71, 72] or topological gradient imaging [73, 74, 75] in order to reconstruct specific parameters of the flaws.

Appendix A. Attenuation law and phase velocity of one-dimensional visco-elastic models

Let us consider the one-dimensional visco-elastic wave equation in frequency domain

$$\rho\omega^2 \hat{u} - \mathbf{M}(\omega) \partial_{xx}^2 \hat{u} = 0, \tag{A.1}$$

where $\mathbf{M}(\omega) = M_1(\omega) + iM_2(\omega)$ is the complex elasticity modulus.

Theorem 7. The attenuation law and phase velocity associated to (A.1) are given by

$$\alpha(\omega) = \omega \sqrt{\frac{\rho Q^2(\omega)}{2M_1(\omega)(1+Q^2(\omega))}} \left\{ \sqrt{1+\frac{1}{Q^2(\omega)}} - 1 \right\}^{\frac{1}{2}},$$

$$v_P(\omega) = \sqrt{\frac{2M_1(\omega)(1+Q^2(\omega))}{\rho Q^2(\omega)}} \left\{ \sqrt{1+\frac{1}{Q^2(\omega)}} + 1 \right\}^{-\frac{1}{2}},$$

$$(A.2)$$

where $Q(\omega)$ is the quality factor defined as

$$Q(\omega) = \frac{M_1(\omega)}{M_2(\omega)}.$$
(A.3)

Proof. The dispersion relation associated to (A.1) is

$$\rho\omega^2 - \mathbf{M}(\omega)k^2 = 0,$$

where $k = \kappa - i\alpha$ is the complex wave number. The associated complex velocity is defined by

$$v_c(\omega) = \frac{\omega}{k} = \sqrt{\frac{\mathbf{M}(\omega)}{\rho}},$$
 (A.4)

so that we can deduce the following definition of the attenuation law and phase velocity

$$\alpha(\omega) = -\omega \operatorname{Im}\left(\frac{1}{v_c(\omega)}\right), \quad v_P(\omega) = \frac{\omega}{\kappa} = \operatorname{Re}\left(\frac{1}{v_c(\omega)}\right)^{-1}.$$
(A.5)

By simply expressing the real and imaginary parts of $v_c(\omega)$ as functions of $\mathbf{M}(\omega)$, we can derive the results (A.2). In the following we denote

$$v_c(\omega) = a_c(\omega) + ib_c(\omega).$$

Using (A.4) we have

$$a_c^2(\omega) - b_c^2(\omega) = \frac{M_1(\omega)}{\rho}, \quad a_c(\omega)b_c(\omega) = \frac{M_2(\omega)}{2\rho}.$$
 (A.6)

Hence, eliminating $b_c(\omega)$ in the first relation of (A.6) yields

$$a_c^4(\omega) - \frac{M_1(\omega)}{\rho}a_c^2(\omega) - \frac{M_2^2(\omega)}{4\rho^2} = 0,$$

from which we can extract the unique positive root

$$a_c^2(\omega) = \frac{M_1(\omega) + |\mathbf{M}(\omega)|}{2\rho}.$$

Using the first relation in (A.6), we have

$$b_c^2(\omega) = a_c^2(\omega) - \frac{M_1(\omega)}{\rho} = \frac{|\mathbf{M}(\omega)| - M_1(\omega)}{2\rho},$$

so that

$$|v_c(\omega)|^2 = a_c^2(\omega) + b_c^2(\omega) = \frac{|\mathbf{M}(\omega)|}{\rho}.$$

Using (A.5), we obtain

$$\alpha(\omega) = \omega \frac{b_c}{|v_c|^2} = \omega \frac{\rho}{|\mathbf{M}(\omega)|} \left\{ \frac{|\mathbf{M}(\omega)| - M_1(\omega)}{2\rho} \right\}^{\frac{1}{2}}$$

Finally, using (A.5), the phase velocity reads

$$v_P(\omega) = \operatorname{Re}\left(\frac{1}{v_c(\omega)}\right)^{-1} = \frac{|v_c|^2}{a_c} = \frac{|\mathbf{M}(\omega)|}{\rho} \left\{\frac{M_1(\omega) + |\mathbf{M}(\omega)|}{2\rho}\right\}^{-\frac{1}{2}},$$

and we conclude by remarking that $|\mathbf{M}(\omega)| = M_1(\omega)\sqrt{1 + \frac{1}{Q^2}}$.

From (A.2), we can verify that the ratio between the attenuation and the (real) wavenumber is

$$\frac{\alpha}{\kappa} = \sqrt{Q^2 + 1} - Q,$$

so that we recover the result given in the Section 2.3 of [25]. Using the expression (A.2) of the attenuation law, we can propose the following characterization of the standard visco-elastic models.

Theorem 8. Assuming "low-loss" and high-frequency asymptotics, i.e. $Q \to +\infty$ and $\omega \to +\infty$, the Kelvin-Voigt, Maxwell and Zener models follow a quadratic, constant and locally linear attenuation law respectively.

Proof. From (A.2), the "low-loss" limit of the attenuation law is

$$\alpha(\omega) \xrightarrow[Q \to +\infty]{} \frac{\omega}{2Q(\omega)} \sqrt{\frac{\rho}{M_1(\omega)}}.$$
(A.7)

The complex modulus associated to the Kelvin-Voigt model reads

$$\mathbf{M}^{\mathrm{kv}}(\omega) = \mathcal{C}^{\mathrm{kv}} + i\omega \mathcal{D}^{\mathrm{kv}},$$

where $\mathcal{C}^{kv} > 0$ and $\mathcal{D}^{kv} > 0$ are scalar values in a one-dimensional context. Using (A.7) we have

$$\alpha^{\mathrm{kv}}(\omega) \xrightarrow[Q \to +\infty]{} \omega^2 \frac{\mathcal{D}^{\mathrm{kv}}}{2\mathcal{C}^{\mathrm{kv}}} \sqrt{\frac{\rho}{\mathcal{C}^{\mathrm{kv}}}},$$

prooving the quadratic dependence of the attenuation w.r.t. the frequency. For the Maxwell case, the complex modulus is given by

$$\mathbf{M}^{\mathrm{mx}}(\omega) = \frac{i\omega \mathcal{D}^{\mathrm{mx}}}{1 + i\omega \tau^{\mathrm{mx}}}, \quad \tau^{\mathrm{mx}} = \frac{\mathcal{D}^{\mathrm{mx}}}{\mathcal{C}^{\mathrm{mx}}},$$

yielding the following real and imaginary parts and quality factor

$$M_1^{\mathrm{mx}}(\omega) = \frac{\omega^2 \tau^{\mathrm{mx}} \mathcal{D}^{\mathrm{mx}}}{1 + (\omega \tau^{\mathrm{mx}})^2}, \quad M_2^{\mathrm{mx}}(\omega) = \frac{\omega \mathcal{D}^{\mathrm{mx}}}{1 + (\omega \tau^{\mathrm{mx}})^2}, \quad Q^{\mathrm{mx}}(\omega) = \omega \tau^{\mathrm{mx}}.$$

The expression of the limit (A.7) reads

$$\alpha^{\mathrm{mx}}(\omega) \underset{Q \to +\infty}{\longrightarrow} \frac{\mathcal{C}^{\mathrm{mx}}}{2\mathcal{D}^{\mathrm{mx}}} \sqrt{\frac{\rho \left(1 + (\omega \tau^{\mathrm{mx}})^2\right)}{\tau^{\mathrm{mx}} \mathcal{D}^{\mathrm{mx}} \omega^2}}.$$

Furthermore, using a high-frequency asymptotic we observe that the Maxwell model follows a constant attenuation law

$$\alpha^{\mathrm{mx}}(\omega) \xrightarrow[Q, \omega \to +\infty]{\mathcal{C}} \frac{\mathcal{C}^{\mathrm{mx}}}{2\mathcal{D}^{\mathrm{mx}}} \sqrt{\frac{\rho}{\mathcal{C}^{\mathrm{mx}}}}$$

Finally, concerning the Zener model, the complex modulus is

$$\mathbf{M}^{\mathrm{zn}}(\omega) = \frac{\mathcal{C}^{\mathrm{zn}} + i\omega\tau^{\mathrm{zn}}\mathcal{D}^{\mathrm{zn}}}{1 + i\omega\tau^{\mathrm{zn}}},$$

with real and imaginary parts defined as follow

$$M_1^{\mathrm{zn}}(\omega) = \frac{\mathcal{C}^{\mathrm{zn}} + (\omega\tau^{\mathrm{zn}})^2 \mathcal{D}^{\mathrm{zn}}}{1 + (\omega\tau^{\mathrm{zn}})^2}, \quad M_2^{\mathrm{zn}}(\omega) = \frac{\omega\tau^{\mathrm{zn}}(\mathcal{D}^{\mathrm{zn}} - \mathcal{C}^{\mathrm{zn}})}{1 + (\omega\tau^{\mathrm{zn}})^2}.$$

The corresponding quality factor is given by

$$Q^{\mathrm{zn}}(\omega) = \frac{\mathcal{C}^{\mathrm{zn}} + (\omega\tau^{\mathrm{zn}})^2 \mathcal{D}^{\mathrm{zn}}}{\omega\tau^{\mathrm{zn}} (\mathcal{D}^{\mathrm{zn}} - \mathcal{C}^{\mathrm{zn}})}$$

The high-frequency asymptotic of the real part of the complex modulus is constant w.r.t. the frequency,

$$M_1^{\mathrm{zn}}(\omega) \xrightarrow[\omega \to +\infty]{} \mathcal{D}^{\mathrm{zn}}.$$

Hence, assuming low-loss and high-frequency asymptotics, the attenuation law of the Zener model satisfies

$$\alpha^{\mathrm{zn}}(\omega) \underset{Q, \, \omega \to +\infty}{\longrightarrow} \frac{\omega}{2Q(\omega)} \sqrt{\frac{\rho}{\mathcal{D}^{\mathrm{zn}}}}.$$

The derivative of the quality factor w.r.t. the angular frequency is

$$\frac{\mathrm{d}Q^{\mathrm{zn}}}{\mathrm{d}\omega}(\omega) = \frac{\tau^{\mathrm{zn}}\left((\omega\tau^{\mathrm{zn}})^2\mathcal{D}^{\mathrm{zn}} - \mathcal{C}^{\mathrm{zn}}\right)}{(\omega\tau^{\mathrm{zn}})^2}$$

and, using the calibration (35), we remark that

$$\frac{\mathrm{d}Q^{\mathrm{zn}}}{\mathrm{d}\omega}(\omega_{\star}) = \frac{2\mathcal{D}_{\star}}{\omega_{\star}} \underset{Q, \, \omega \to +\infty}{\longrightarrow} 0.$$

Hence, the attenuation law of the Zener model is linear locally, i.e. around the frequency of interest ω_{\star} .
