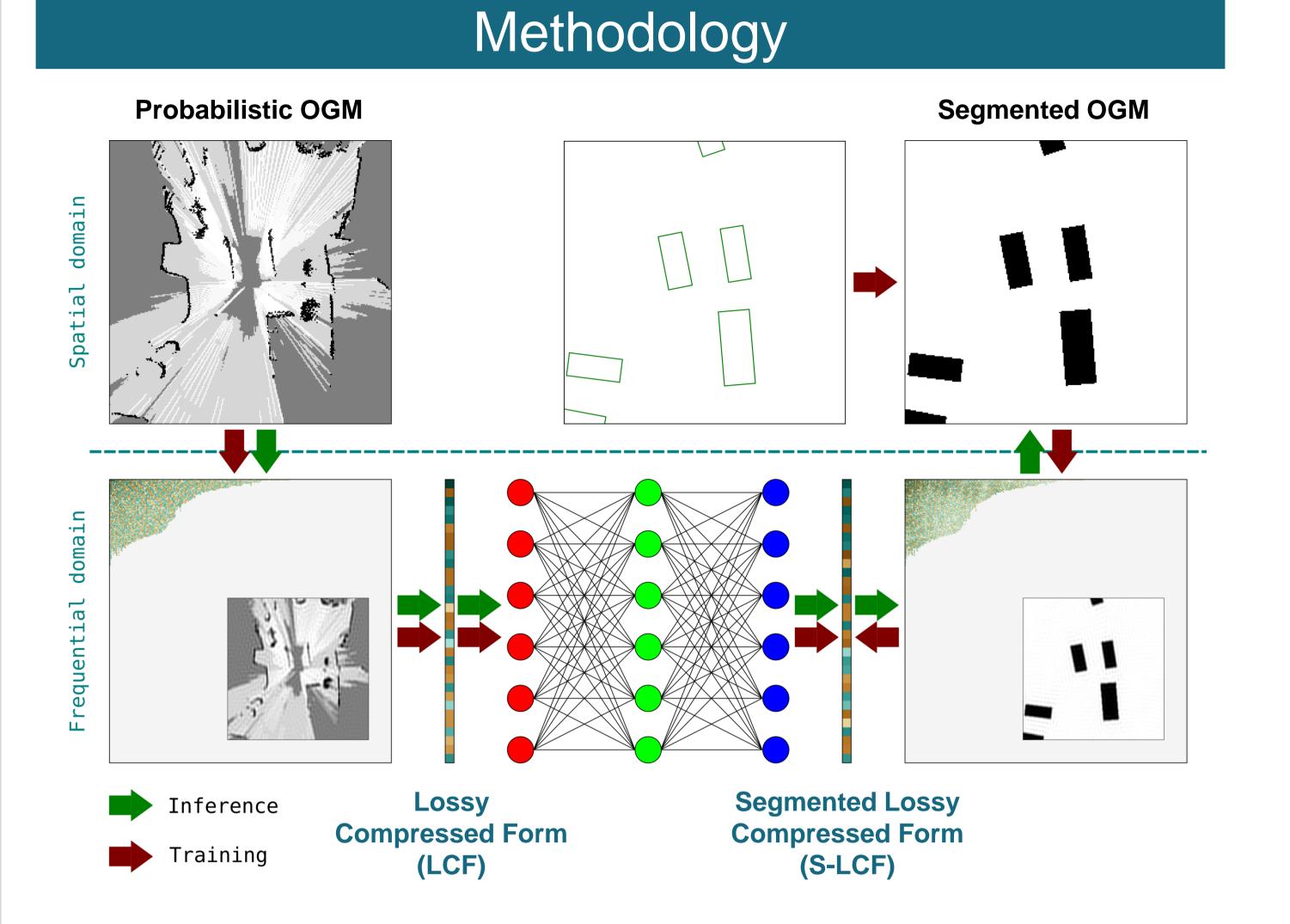
### Context

Binary segmentation applied to robotics applications

- Used in robotics perception : classification of pixels of an image (into vehicles, road, pedestrians, etc.) or points of a point cloud
- Real-time execution on resources-constrained embedded chips

# State Of The Art

Typical Artificial Neural Networks (ANNs) for binary segmentation use CNNs directly inferred on images (U-Net [1]) or on a 2D projection of a LiDAR point cloud (VoxNet [2], RangeNet++ [3])



• Computationally expensive due to the size of the input tensor

Frequency transformation is used to enrich the input of ANNs, but also for image translation [4] and manipulation [5] in multimodal neural networks

• It is not used to predict frequency domain output, nor to reduce the costs

# Objective

#### Binary segmentation under the following constraints

- Reduction of computational costs in order to envision an integration into embedded resource constrained hardware in the future
- Fully configurable method regarding the available computational resources

# Use-case : Binary Segmentation of OGM

#### Probabilistic Occupancy Grid Map (OGM) [6]

- Representation of the environment around a car into a bird's eye view image composed of 65,536 squared cells of size 10 cm x 10 cm
- A probability value between 0 and 1 estimates the confidence about the

#### Step #1 - Compression into Frequency Domain

**Input** : Probabilistic Occupancy Grid Map (OGM)

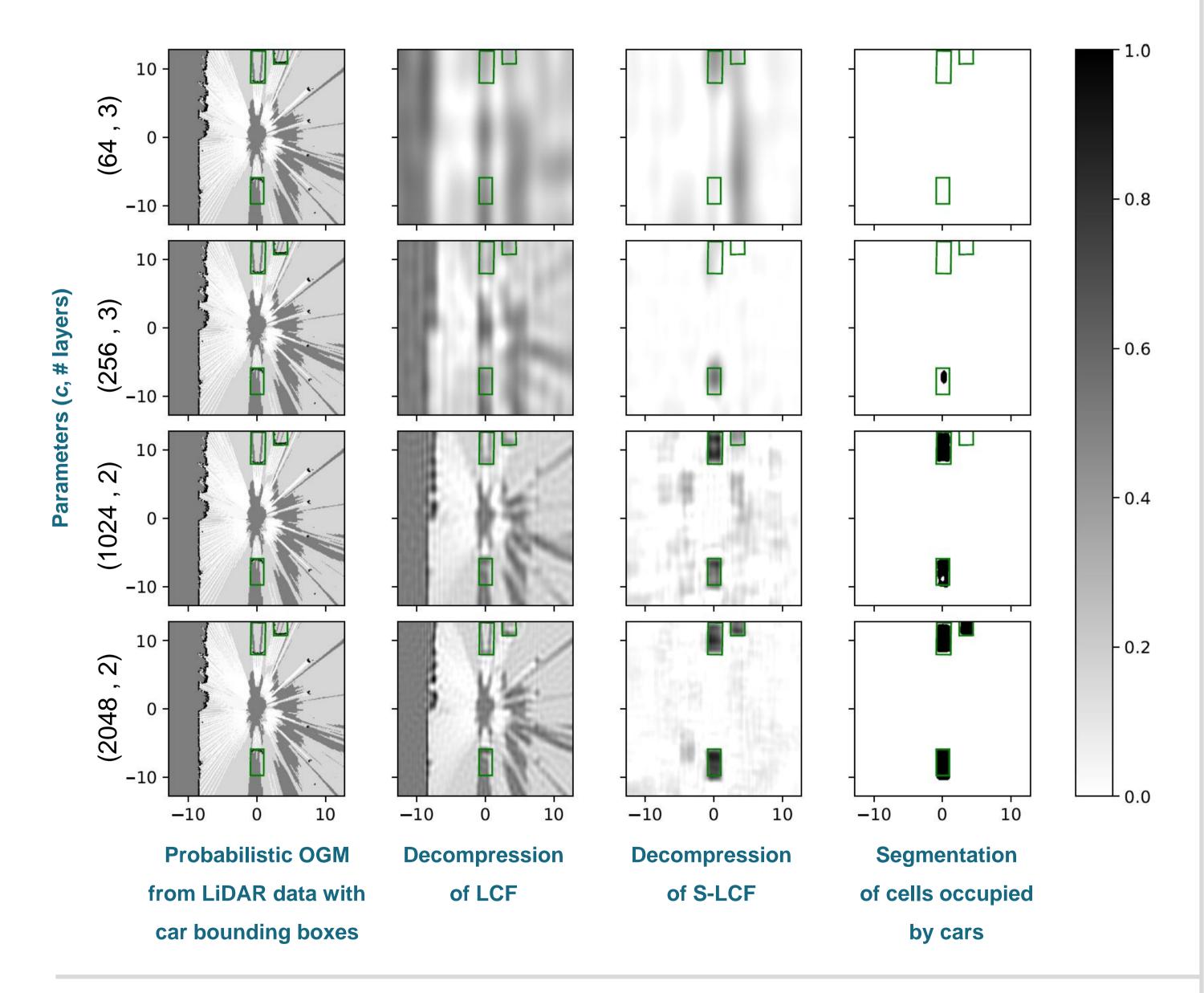
- 1. Transformation of OGM into its spectrum obtained by the **Discrete Cosine Transform (DCT)**
- 2. Truncation of the obtained spectrum via an optimal mask (learnt based on the training set) in order to select and keep only c number of frequencies, where c < number of OGM cells</p>
- 3. Flattening of the truncated spectrum into a 1D array
- **Output** : Lossy Compressed Form (LCF) in the form of 1D array of size *c* containing the spectrum coefficients relative to the selected frequencies

### Step #2 – <u>Segmentation of Compressed Input</u>

occupancy state of each cell

**Objective** : Segmentation of cells occupied by cars (binary segmentation)

**Dataset** : Original and segmented OGMs built from the bounding boxes of the labelled cars within the Waymo Open [7] dataset containing 198,068 traffic scenes



**Input:** Lossy Compressed Form (LCF)

- 1. Use ANN to generate a Segmented Lossy Compressed Form (S-LCF)
  - Architecture : 2 or 3 dense layers of *c* neurons, with ReLU activation function for all layers except for the last one
  - Training : Adam optimizer with early stopping
- 2. Decompression of S-LCF into spatial domain
- 3. Binary segmentation of the decompressed form by thresholding

Output: Binary OGM where cells occupied by cars are segmented

# **Experimental Results**

- Quantitative results : Inference times < 2 ms for Average Precision (AP) > 0.5, starting with compression parameter c ≥ 512 (compression ratios ranging from 1/128 to 1/32)
- Qualitative results show an ability of the neural networks to segment properly OGMs even under very degraded compressed forms
